- Rangers Patrol all 280+ Parks in the City of Madison
- Patrol Hours generally are 9am to midnight during the summer
- Ranger Patrol Methods
 - Vehicle
 - Foot
 - UTV



Ordinance Enforcement

- Enforce park rules in all 280+ Madison Parks
 - Ordinance Violation Notices
 - Municipal Citations
 - Warnings
- Work with local Police and Sheriff's Office
 - Dispatch
 - CAD
- Park Behavioral Policy
 - Issue Park Bans
- Respond to citizen and staff complaints/concerns
