City Attorney Michael May reviewed the language in APM-3 that dealt with complaints against elected officials. Under the existing APM there was no mention of complaints against elected officials. The revised APM-3 provides a process for complaints against elected officials.

If a complaint is made, the City Attorney, Human Resource Director and Affirmative Action Office will investigate and make a public report of their findings. There are no remedies for elected officials as there are for employees (e.g. suspension, termination, etc...) The only remedies when elected officials are involved is through the election process or censure by the Common Council.

If there is a violation and complaint based on the Ethics Code, complaints would continue to be filed and dealt with by the Ethics Board. If the complaint is a violation of State law it would be investigated and dealt with by the District Attorney's office.
