APPROVAL OF MINUTES

Hughes made a motion and a second by Alder Slack to approve the minutes from the10/25/23 meeting. The motion was approved by a voice vote/other.

PUBLIC COMMENT

1. <u>80707</u> Public Comment

There was no public comment.

NEW BUSINESS

2. 80708 Approval of the 2024-2025 Mall Concourse Vending Map.

Alder Slack made a motion and a second by Hughes to approve the 2024-3035 Mall Concourse Vending Map as presented. The motion was approved by a voice vote/other.

REPORTS

3. Late Night Vending planning: updates, input gathering and timeline for creation of a program for 700/800 State Street Night Vending Area for the 2024-2025

vending season, per MGO 9.136(1)(n)3.c.

Staff shared that there will be an equity analysis completed on the State Street Night Vending recommendations. These results will be shared at the January meeting along with the draft ordinance changes.

Staff also shared that two citations were issued on 11/29/23. One was issued to Sarbaro Queretano and one to JD's for vending violations related to their current Late Night Vending operations.

4. <u>76255</u> Street Vending Staff Report

The staff report was reviewed. Staff shared the 2024 Vending Oversight Committee meeting dates and noted there will not be a December meeting in 2023 and if a meeting is needed in December 2024 it will be rescheduled from the 12/25/24 current date.

Staff also shared that the Mayor has approved appointing Ashleigh Hacker to the new full voting Citywide member of the VOC. The appointment approval will be introduced at the 12/5/23 Common Council meeting and the 1/9/24 Common Council Meeting for final approval.

The Street Vending Monitor position was posted and closed on 11/28/23. Staff will be scheduling and conducting interviews to fill the position.

Staff reminded the committee members that they must complete their annual Statement of Interest form that was sent out by the Clerk's Office. This annual form is due on 1/2/24.

A motion was made by Alder Verveer and a second by Alder Slack to adjourn the meeting. The motion was passed by a voice vote/other. The meeting was adjourned at 5:40pm.
