Madison Parks Qualifying Discounts Program (QDP)

At Madison Parks, we are dedicated to providing an exceptional system of parks, natural resources, and recreational opportunities that enhance the quality of life for our community. As part of our ongoing efforts to make our parks and facilities accessible to all, we are pleased to offer the **Qualifying Discounts Program (QDP)**. This initiative is designed to remove financial barriers for qualifying individuals and groups who utilize our parks, open spaces, and recreational facilities.

To apply for the QDP, please follow the instructions outlined below. Note that discounts will only apply to reservations made after the completion of the QDP process.

How the QDP Works:


- Discount Eligibility: Discounts are applicable only to reservations made after the QDP process is completed. Reservations submitted before the discount is applied will not qualify. If you cancel and resubmit reservations, the standard cancellation policy applies.
- Complete and Submit the Form: Fill out this form and save it with your organization's name (if applicable) or your last name and email it to QDP@cityofmadison.com.
- 3. **Confirmation:** Madison Parks staff will review your form, apply the discount to your account, and email you the results.
- 4. **Reservations:** Public reservations open each year on the third Monday in February. If the date has passed, you may submit reservations at any time. If the date has not yet arrived, please wait until the opening date to submit your reservation.

Rules & Exceptions:

- Ensure that the responses on your form accurately reflect your organization.
- Specialized athletic fields, shelter reservations, field lighting, and additional permits are not included in the QDP.
- Discounts are not retroactive and will expire each year, requiring you to complete the form annually.



Enter reservation requests via online platform in advance for Parks to review.	Rain-out notifications via email.
Keep all spaces (fields, shelters, etc.) in a neat and orderly manner. Place all trash in proper receptacles.	Initial field setup as determined by the Madison Parks Division.
Remove all items from the area after each reservation.	
No permanent or semi-permanent advertising signs or billboards on the property.	
Provide portable toilets if needed; public restrooms are open approximately April-October where available.	
Discretion on inclement weather/field conditions, damage fees may apply.	
Ongoing field lining needs.	
Provide end of season reporting (template provided), as requested from Madison Parks. Report due no later than one week following last reservation.
