History of the Foundation

The Madison Park and Pleasure Drive Association was organized in 1892 with a goal of developing and maintaining scenic drives and parks in and around Madison. Organizers wanted to ensure that people had the opportunity to enjoy greenspace and natural areas and were intent on creating luxuriant spaces for Sunday carriage rides. Support for the association was so strong that as much as 75% of the population contributed time, talents, and resources. Many of the largest contributors are familiar as surnames memorialized in Madison park, street, and building names: Tenney, Vilas, Brittingham.

Edward Owen and John Olin founded the association, but Olin is regarded as "the father of Madison's Park System." His foresight led to the development and preservation of 229 (269) acres of parks within the city limits by 1909. He helped raise nearly a quarter of a million dollars in private donations and influenced park development throughout the city. Olin advocated for parklands along the Yahara River, obtained the funding for what would become Wingra Park, and helped establish Brittingham Park. He also recruited landscape architect John Nolen as the city's first parks superintendent in 1908, and Nolen's plan for A Model City influenced many land-use decisions.

During the Association's 37 years of existence, it acquired a remarkable 290 acres of parks and park lands for the public's use. The Madison Park and Pleasure Drive Association functioned as the city's unofficial parks department until 1931 when the association began to transfer responsibilities to the City of Madison. By 1938, the association had completed the transfer of its property and resources to the city. The momentum of generosity never faltered. Indeed, the city continued to accept gifts of parkland and to build playgrounds, shelters, gardens, and other improvements upon those gifts. Warner Park, named for Madison Parks and Pleasure Drive Association leader Ernest Warner, was established in 1939, Marshall Park in 1956, Garner in 1965. Owen conservancy was dedicated in 1972. As the city grew outward, emerging neighborhoods deeded lands to Madison for park space, some of which awaits development. Neighborhood and civic groups, likewise, have remained active raising funds, maintaining gardens and helping to build much needed amenities. The Warner Park Community Recreation Center which opened in 1999 and the Goodman Community Pool which opened in 2005 are living examples of the spirit of the Park and Pleasure Drive's private citizen activism.

Citizen support for Madison parks was again formalized in 2002 when the Madison Parks Foundation was incorporated. The Madison Parks Foundation began fundraising for the Goodman Pool in 2003 and became Madison Parks' fundraising partner for many of its important projects like the Brittingham Boat Renovation, the construction of Veterans Memorial Park, the Tenney Park Shelter Renovation, the addition of the Madison's first Skate Park and assists many neighborhood friends groups with their fundraising efforts.

The Foundation hired its first employee in 2013, and then successfully fundraised \$300,000 for two additional splash parks. Over the next few years Madison Parks Foundation launched a Tributes & Memorials program, established an endowment, introduced historical signage in some of its most iconic parks, and became a fundraising partner for a new pickleball complex and for a national grant to connect children with nature. Other initiatives include renaming a park to honor East High School's beloved principal, Milton McPike, sponsoring the Learn-to Series that provides free programming in our parks for the community, fundraising for KNOW (Kids Need Opportunities at Warner) to provide much needed youth programming at Warner Park Community Recreation Center, and launching a capital campaign for additional fully accessible playgrounds throughout the city.

Foundation Description

The Madison Parks Foundation is a 501C3 non-profit organization that supports the Madison Parks Division. The Madison Parks Foundation is a dedicated group of volunteer board members and one full time employee that focuses their efforts to advocate for our city's parks and open spaces, we are committed to identifying and supporting park improvement opportunities by encouraging and mobilizing the financial support of neighborhood groups, foundations and citizens.

Mission

Madison Parks Foundation works to protect and improve our city parks and open spaces for all people, forever.

The intended purpose of the Madison Parks Foundation is to acquire financial resources through contributions and grants to make park improvements and support park programming. As the official affiliate organization of the Madison Parks Division, we process and receipt all gifts to parks of \$10,000 or more. One of the requirements of the affiliate organization status is a yearly audit that we provide to the City of Madison Treasurer's office. The resources of the Madison Parks Foundation are not intended to replace or substitute for tax revenues generated for the annual ongoing maintenance activities of the Madison Parks Division.

The fundraising efforts of MPF focuses on broad scoped and wide-reaching programs and projects that embrace the themes of inclusion and accessibility for all and reserves the right to chose the fundraising goals of projects and programs that are feasible for a volunteer board and one employee to accomplish.

The Madison Parks Foundation will utilize several methods to fundraise for general operating support and for its initiatives which include mailed appeals, grant writing, social media, press releases, website updates, quarterly e-newsletters, email appeals, events and the Parks Division's website, social media and emails.

Each year, the goals and initiatives will be reviewed to make adjustments/improvements as necessary and evaluate "lessons learned" with initiatives to improve our process of selecting additional or new initiatives.

Operational support is essential to the sustainability of the Madison Parks Foundation. This support is attained through the annual appeal, grant writing and the Tributes & Memorial program.

Fundraising and stewardship of donors and prospects are accomplished by building trust over time. This process is specific to each donor and prospect and cannot be rushed or be measured quantifiably. Additionally, it is essential for the Madison Parks Foundation to maintain their integrity as an organization and therefore donor information is strictly confidential and will not be shared with the public or other organizations or entities. As a group of volunteers and one employee, our organization recognizes the challenges of fundraising for each individual neighborhood or Friends group and serves these groups with providing bookkeeping, receipting and providing tax-deductibility to their donors, once a fund established at MPF.



Initiatives

Through our initiatives, we look to assist the Madison Parks Division by making our parks more inclusive through inspiring programming and accessibility. When the board established our initiatives, it was imperative to select programs and projects that had a broad scope to enrich the lives of as many park users as possible.

The Madison Parks Foundation is working on making our parks more inclusive, equitable and accessible through our initiatives:

- Accessible & Inclusive Parks & Playgrounds currently there are 4 accessible playgrounds within our 176 playgrounds and the additional playground at Reindahl Park coming in 2025/2026. With these five accessible & inclusive playgrounds, most residents would be within a 5-mile radius of one of the playgrounds. It is important to add these assets to our parks system to be more inclusive, since 20% of our population is affected by a disability whether it is physical or cognitive. The Accessible Playgrounds project provides 100,000 Madison households access to a fully accessible playground within a two-mile radius. MPF continues its efforts of identifying other opportunities to add accessible features across the Parks system, like additional beach mats, spraygrounds and water wheelchairs.
- Sponsoring the *Learning Series* which provides instruction and equipment to learn to try different activities in our parks like playing Cricket, birdwatching, outdoor photography, cross country skiing, and informative and history learning sessions. We hope to expand this program by purchasing additional equipment and supplies to allow more residents to participate, as well as sustain the programming for years to come.
- The KNOW program (Kids Need Opportunities at Warner) Teen Night, Family Fun Night and the 3ON3 Basketball Tournament Series provide meaningful opportunities for youth and keep them out of situations where they may engage in negative behaviors. These programs, along with daily open gyms, are the new cornerstone of the Warner Park Community Recreation Center (WPCRC). We have met our fundraising goal of raising \$150,000 to insure complimentary and engaging programming continues for this economically challenged area in our community, however we will continue our efforts to raise money for this worthy program.
- **Parks For All Trust Campaign** with a \$10 million fundraising goal, the will provide a sustainable source of funds to use towards our efforts of providing accessible parks and programs to the community. Making our parks "accessible" means addressing physical, cognitive, and socioeconomic obstacles that keep people from reaching and enjoying our parks. Those obstacles will continue to change and grow long into the future, so our ability to fund solutions must be flexible. The specific initiatives will change, but our focus will always be the same: parks should be for all people, forever.
- **Swimming Scholarships** to ensure that the community pool is accessible and inclusive regardless of income.
- Serve as a *Liaison for continued growth, development and advancement* of the Parks Division.
- To enhance, support and expand the growing needs of our community **Dog Parks**.
