Most of our customers are regulars whom we know and have a relationship where they behave and cooperate with us.

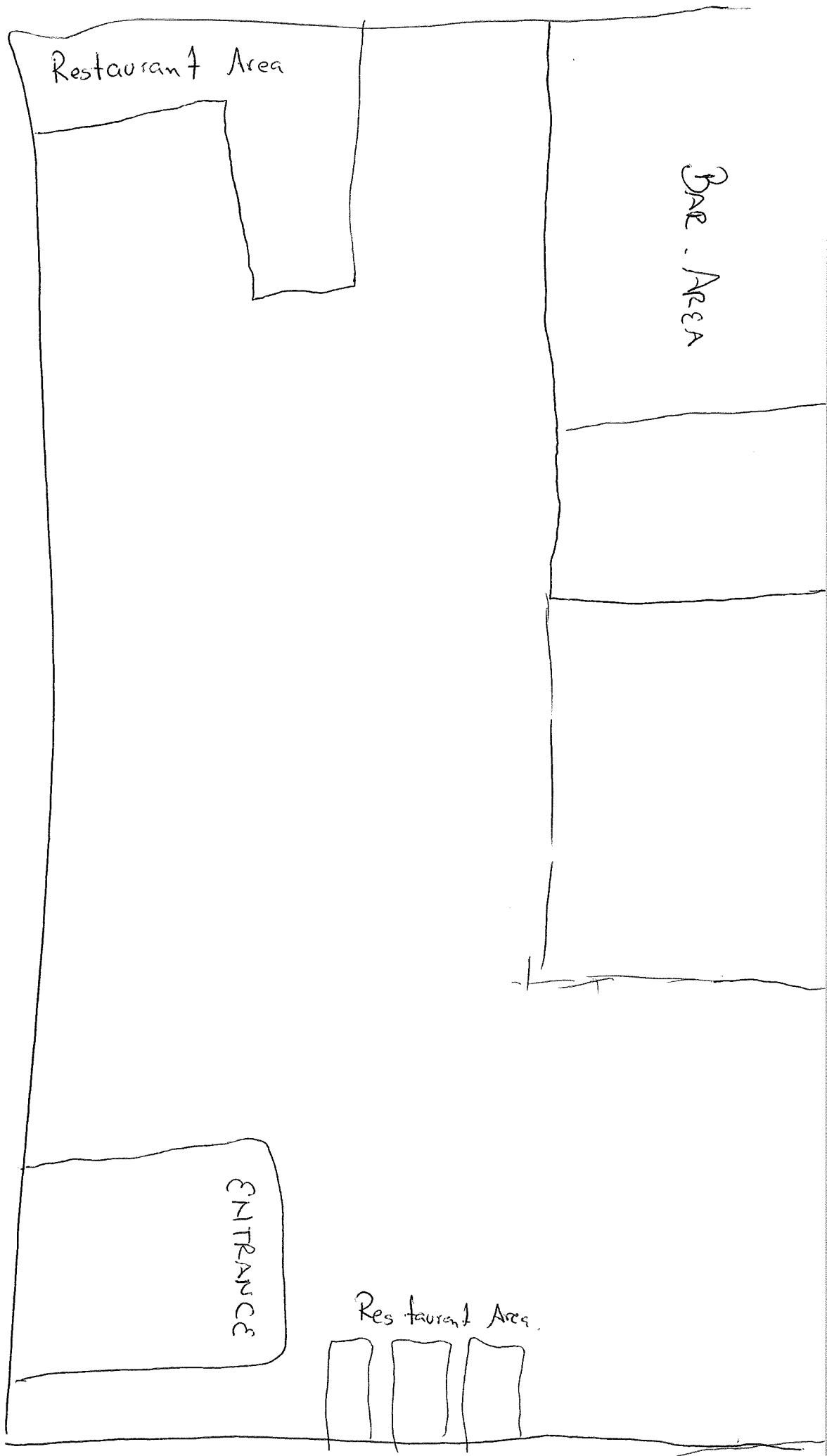

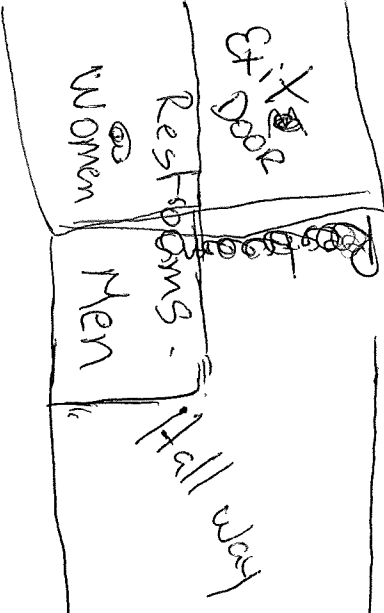
