He no longer chairs the Workforce and Economic Development Commission, however the resolution to allow Dane County to participate in the PACE WI commission may go through the Environment + Natural Resources committee chaired by Patrick Downing. I don't know if Dane County Corporation Counsel has signed off on it. I'm cc:ing John Hochkammer and Jason Stringer on this e-mail in case they have more current information. They attended the same meeting with Supvrs. Miles and Downing at the City County building two weeks ago.
