- Legistar needs improvement in terms of navigation, ability to find agenda, being interactive, and allowing comment.
- Legistar can accommodate a comment method.
- City's 311 effort and new Legistar are going out for RFPs.
- Legistar should include a subscription service, ability to download calendars, messages to all members of a committee, and ticket tracking for information and inquiries.
- City needs to add the ability for residents to watch and speak remotely.
- Problem of transit reiterated; hours to get downtown for a 3 minute talk.
- Maybe do standard non-business items at 5:30 p.m. or 6:00 p.m., so at 6:30 p.m. the real meeting starts.

6. DISCUSSION ABOUT WHETHER A TRAINING PROGRAM SHOULD BE ESTABLISHED FOR COMMON COUNCIL MEMBERS.

- Yes, more.
- Have on demand pre-recorded training. Have on line training open to the public. Include relationship training.
- Early training for alders on Legistar, the actual agenda, the consent agenda and demonstrate live how these work. Have a mock Council meeting.
