Entertainment and Security Information

Number of security personnel and how they will be utilized: 3 or more depending on the event and crowd expected

Description of clothing to identify security personnel: All black with vest labeled Security.

Plan to handle control and clearance of the parking lot during hours of operation and at closing time: Lights are scheduled to come on twenty five minutes before event ends. Last song is played 10 minutes before close. No parking lot.

How will the entrance line be managed and controlled: No more than five persons outside & five inside while persons are being searched.

Plan for unruly patrons, intoxicated patrons, and physical disturbances: All guards are trained in deescalations, so conversations are always before any force is used. Force is used only if patrons become physical they will be removed & banned.

Underage drinking and fake ID plan: Security uses ur id checkers to detect fake ids and have been trained to detect fake ids.

Plan to control and supervise patrons under twenty-one (21) years of age: No one under 21 years of age is allowed due to the serving of liquor.

How will orderly appearance and operation of the premises be maintained in regard to litter and noise: No out food or drinks are allowed in, but carryout foods is allowed. Premises is checked every night after events.
