#### Report of the Madison Police Department

Alcohol-related violence on and near State Street

Nicole DeMotto, analyst for the Madison Police Department, presented the committee with the report attached to these minutes. Ms. DeMotto reported that, in the State Street area (Sector 403), the suspects in 73 percent of substantial battery reports are believed to have used alcohol and the victims in 77 percent of substantial battery police reports are believed to have used alcohol. Twenty percent of these battery victims are so impaired that they are completely unable to defend themselves in an attack. Ms. DeMotto also reported that 63 percent of substantial batteries in Sector 403 occur between midnight and 3 a.m.

The Madison Police Department recommended limiting the density of liquor licenses in Madison. Police Chief Noble Wray said enough is enough, and asked the committee to not continue adding to the liquor license density in Sector 403.

Alderperson Olson said over-serving is one management problem that needs to be addressed. Chief Wray said he agrees that the City must also advocate strong management practices.
