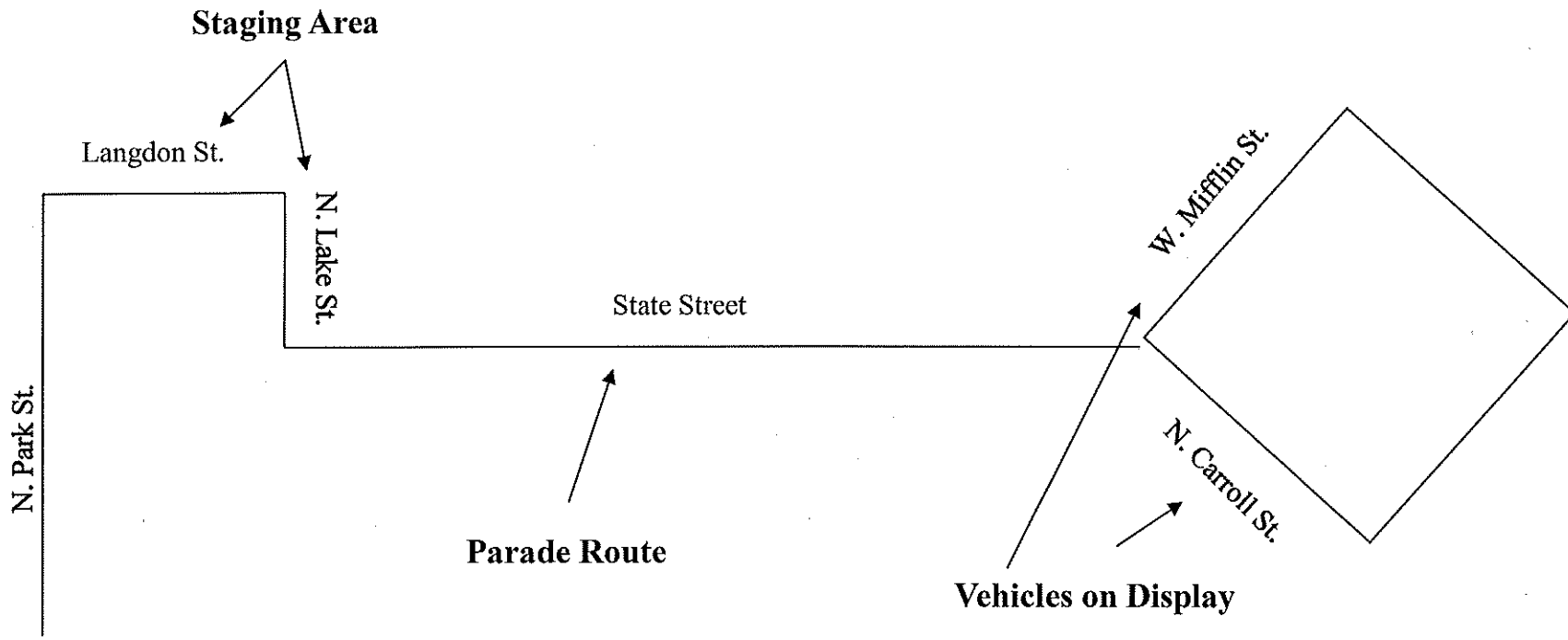

- Parade finishes & fire apparatus assemble on 10 block of N. Carroll Street & 10 block of W. Mifflin Street for static display

Safety & Security Plan

We anticipate over 30 fire apparatus staffed by firefighters, EMTs and paramedics. Many of these vehicles carry emergency medical equipment for any injuries or medical emergencies that may occur.

Personnel from the Madison Fire Department and numerous Dane County fire departments will be in attendance with radios & cell phones to provide communications in case of an emergency.

The Dane County Fire Chiefs parade draws a family-friendly crowd and has been very successful every year that we have hosted it. All of the participating fire departments enjoy this event and will be reminded to be safe and look out for any unsafe situations.
