They have been meeting twice a month, are in the final stages of voting on the last of the recommendations and are collecting any additional recommendations from community members. He was hoping that they can finish a final report by the February 26 deadline.

Assistant City Attorney Marci Paulsen and City Attorney Mike May were available to answer questions and address concerns about the report writer contract and the adopted resolution.

Ald. Kemble suggested that the new Common Council Legislative Analyst be dedicated to working on the report with the City Attorney's office and the MPD Policy & Procedures Ad Hoc Committee.

Ald. Carter suggested that Ms. Rothburd be told that the \$10,000 was a flat fee and if she was unable to accept the contract the new legislative analyst would be tasked with developing the final report.
