The Board of Public Works and the City Engineer having made reports of all proceedings in relation to the improvement of 115 King Street Vault Assessment District - 2011 pursuant to a resolution of the Common Council, ID No. 23615 which resolution will be adopted on 9/6/11 in accordance with Sec. 66.0701 (formerly Sec. 66.62) of the Wisconsin Statutes and Sec. 4.09 of the Madison General Ordinances and having in all things duly conformed to the order of the Common Council in relation thereto, and the provisions of the Madison General Ordinances and the Wisconsin Statutes in such case made and provided, and the Common Council being fully advised.

BE IT RESOLVED:
