SUMMARY:

At its meeting of August 13, 2008, the Urban Design Commission **GRANTED FINAL APPROVAL** for the construction of a new gas station/convenience store located at 2702 East Washington Avenue, in Urban Design District No. 5. Appearing on behalf of the project was John Sutton, who gave an overview of the project and changes since the last meeting, including: replacing the walk-up window with a door, removing the side door, enhancing the landscaping, among others. He stated that there is proposed to be signage on the street side face of the canopy, and on the building between the first and second stories. An existing freestanding sign will be removed and replaced with a reader board sign. Sutton also noted that the lighting under the canopy will not change. The Commission discussed the perpendicular parking spaces and options for improving their function and adding landscaping.

ACTION:

On a motion by Barnett, seconded by Slayton, the Urban Design Commission **GRANTED FINAL APPROVAL** for the construction of a new gas station/convenience store located at 2702 East Washington Avenue, in Urban Design District No. 5, subject to the following conditions:

- 1. Staff approval of a small canopy over the door and window, instead of two canvas awnings.
- 2. Staff approval of centering the two parallel parking spaces along the sidewalk, adding greenspace on both sides of these spaces, adding greenspace along the edge of the western driveway, and including at least one shade tree in that area to discourage traffic cutting across to Kedzie Street.
- 3. Staff approval of lighting levels under the canopy with a maximum of 20 footcandles.
- 4. All signage must be approved by the Urban Design Commission.

The motion passed on a vote of (8-0).
