City of Madison Park staff recommends approval of The Irish-Celtic Fest at Elver Park old shelter on Sunday, August 5th, from 11:00 AM-7:00 PM, based on the following conditions:

- 1. Aldermanic notification is required by the event sponsor, no less than two weeks prior to the event.
- 2. Irish Fest event sponsor must cooperate and share the parking lot with the AIDS Network bike ride pit stop, previously scheduled on August 5 from 10:00 AM-3:00 PM, at the new park shelter.
- No alcohol is to be sold or served at this event.
- 4. Public amplification will be limited to a 4-hour block of time.
- 5. Event sponsor is responsible for picking up all trash and litter immediately following the event.
- 6. A park site plan shall be submitted, reviewed, and approved by parks staff.
- 7. A pre-event park walk through shall be done with event planners and park staff no less than one week prior to the event.
- 8. Event planner shall provide a Certificate of Insurance with a minimum of \$1 million of general liability coverage and listing the City of Madison as an additional insured.
- 9. Event sponsor shall pay all park fees and obtain all of the necessary permits no later than one week prior to event. This includes a \$1,000 park damage deposit.
