142. DISCUSSION ITEM: Consider site assignments for all four Late Night Vending areas with the possibility of limiting large carts to the 700 block of State Street (a.k.a. The Library Mall).

After discussion, Verveer moved and Richards seconded that Hansen invite all licensed Late Night Vendors, impacted restaurant operators and any other interested parties to the next VOC meeting to discuss the future of Late Night Vending. The motion passed.

143. DISCUSSION ITEM: A draft resolution that applies uniformity to all street vending categories having seniority status based on first day licensed.

After discussion, the committee decided to ask Hansen to have Assistant City Attorney Mainella revise the existing draft with the following three changes: (1) That seniority become consecutive years only with no years off, (2) that when two vendors share a Mall/Concourse Arts & Crafts Vendor License, the seniority number of the vendor with the lower seniority of the two would be used to determine their shared seniority level and that, if the same two vendors stop sharing the license, the vendor with the higher seniority number will be restored to their higher seniority level, and (3) that the word "their" be deleted from the second paragraph of section A of the existing draft, so that it would read "has remained licensed for the same number of consecutive years, rank order...."

144. ACTION ITEM: Approve Southeast Campus Vending Area Map, including perimeter of vending area, location, and size of vending sites (per 9.13(10)(a) and (d) requiring the VOC to affirmatively approve the official map).

After discussion, the committee decided to recommend that the Southeast Campus Vending Area map be approved with the deletion of site U9. Verveer moved and Pham-Remmele seconded that the map be approved as specified above. The motion passed. It was agreed that the addition of other sites may occur in the future of this new vending area..

STREET VENDING COORDINATOR'S REPORT: Which would include numbers licensed in each vending category, any enforcement, revocation of a street vending license, vending in other communities, an invitation to a San Francisco street food festival, number of organizations requesting banner assignments, and the hiring of the Street Vending Monitor.

Hansen said that the preceding weeks had been busy with the start of the new street vending season on April 15th and the hiring of the Street Vendor Monitor, whose first day was Monday April 12th. He said that Monitor training was ongoing and also a challenge at this time of year. Hansen added that the previous Monitor had made some ordinance interpretation blunders in his first months and Hansen wanted to avoid having that happen with his new assistant.

Richards asked if the increased fee for banners had impacted the number of organizations applying for banner space. Hansen said that there were more organizations than ever, adding that no one was complaining about the higher vending fees. They were just paying for them.

Hansen mentioned the inaugural San Francisco Street Food Festival Conference which he had been invited to help organize and attend, scheduled for August 21st, 2010.

Richards moved and Pham-Remmele seconded that the meeting be adjourned. The motion passed. Foxgrover adjourned the meeting at 7:11 p.m.
