Assistant City Attorney Zilavy announced the parties had agreed to stipulate regarding complaint counts number 1 (with some changes), 2, 4, 5, 7, 8, 13, 14 (with additional language), 15, 17, 18, 20 (with language changes), 21, 24, and 26 (with language changes).

Counts 6 and 22 were withdrawn by the city.

Count 27 was not stipulated to but had been testified to, according to ACA Zilavy.

Mr. Delyea for the respondent moved to strike or dismiss items 9,10, and 11. Chair Hart said he would take the request under advisement.

The city of Madison called Officer David Mertz, who was questioned by ACA Zilavy regarding count 12 of the complaint, followed by cross-examination from Mr. Delyea. The committee was given the option of asking questions of the witness.

The city of Madison called Officer Adrian Alan, who was questioned by ACA Zilavy regarding counts 16 and 19 of the complaint, followed by cross-examination from Mr. Delyea. The committee was given the option of asking questions of the witness.
