**CONTRACT FOR THE CONSTRUCTION OF PUBLIC IMPROVEMENTS

THIS AGREEMENT, made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between University Research Park, Incorporated, of Madison, Wisconsin, hereinafter the "Developer", and the City of Madison, hereinafter the "City", a municipal corporation located in Dane County, Wisconsin.

Said contract is hereby amended as follows:

Page 9, SECTION I – GENERAL CONDITIONS

Paragraph O., 2., a. – increase City Traffic Engineering Division deposit by \$6,000.00 to a total of \$9,000.00. Increase additional deposit amount required with contract from \$7,800.00 to \$13,800.00.

Paragraph P., 1. – increase surety amount by \$3,600.00 to a total of \$133,600.00

Page 11, SECTION II - SUPPLEMENTAL CONDITIONS, add the following sections:

G. The Developer shall install a public traffic island and crosswalk in Rosa Road per plans approved by the City Engineer.

All other terms and conditions of said contract remain unchanged.
