I. STANDARD:

Triple Shift Entertainment will provide a safe, friendly, and courteous environment for guests and associates. When the Company believes a guest's behavior is inconsistent with this goal, adversely impacts operations or violates its standards, and the guest does not correct the behavior, the Company may issue a Trespass Notice to the guest (not allowing the guest to enter or use its venues or property) for a period of time, not to exceed 12 months.

II. OPERATING PROCEDURE:


1. Persons who have engaged, or are reasonably likely to engage, in criminal activity, a violation of Company policy, or conduct that is or may reasonably be deemed to be threatening, disruptive, or violent may be issued a Trespass Notice. Reasons for a Trespass Notice:
 - a. Engaged in criminal/illegal activity – Distribution or consumption of drugs or alcohol, weapons, reckless driving, or any other behavior that is illegal.
 - b. Solicitation – The request, encouragement, or direction of one person by another to commit a serious criminal offense or selling goods and services onsite without authorization.
 - c. Verbal or physical confrontations – Gang signals, Inappropriate gestures, racial slurs, physical fighting, etc.
 - d. Other Examples – littering, parking cars at the venue without approval or without a business purpose, terminated employee, behavior that is not conducive to a family environment in the venue, parking lot, or anywhere on company property.
2. The highest-ranking person at the center must fully investigate the matter to obtain a complete understanding of the facts and circumstances.
 - a. This person should also document their efforts made to resolve the issue prior to implementing the Trespass Notice.
3. The Trespass Notice may be given orally or in writing at the time of the concerning conduct, or later via a written notification sent to the banned person via email, first-class mail and/or certified mail. A written Trespass Notice will inform the person:
 - a. That they are barred from all Company properties.
 - b. Of the duration of the ban;
 - c. Of the reason for the ban; and
 - d. That the police will be involved if they return.
4. The General Manager and Chief Operating Officer must be notified, and they must approve the Trespass Notice.
5. A picture of the person must be kept in a binder with the details of the Trespass Notice.
 - a. The picture can be taken of the person on video or in person.

- a. Use good judgement in handling the situation.
 - b. Courteously approach the guest, politely tell them about the Company's standard and the inappropriate behavior, and ask the guest to cease such behavior.
 - c. Quietly and politely ask the guest to leave if the inappropriate behavior continues.
 - d. Alert another associate prior to approaching the guest. This associate must watch for any escalation and assist or call the police as appropriate.
 - e. Call the police and the District Operations Manager
 - f. Not humiliate, physically threaten nor detain/touch the guest.
 - g. Tell the police the facts when they arrive. An arrest should not be demanded; the police may decide what to do.
 - h. Not sign a complaint or any other document on behalf of Triple Shift Entertainment.
6. A guest or another associate must not be touched except:
- a. In the case of self-defense.
 - b. To administer CPR or other medical attention, for which the associate is certified and qualified; or at the request of the guest in an emergency; or in a life-threatening situation where the associate or guest cannot request assistance.
 - c. At the lawful direction of law enforcement personnel acting within the scope of their employment.

6. If the guest attempts to return to the venue after receipt of the Trespass Notice, venue management must:

- a. Avoid the use of physical force or contact.
- b. Notify the Police Department if the guest will not leave the center.
- c. Notify the General Manager and/or the Chief Operating Officer.
