1. CALL TO ORDER (Chairperson Levin)

Chairperson Levin called the meeting to order at 5:30 PM.

2. APPROVAL OF MINUTES

A motion was made by McDonnell, seconded by Lee, to Approve the DCC Minutes of 3-20-08, with minor changes. The motion passed by voice vote.

3. PUBLIC COMMENT (Each speaker limited to 3 minutes)

4. STAFF REPORTS

A. Central Police District (Officer Mark Brown)

-Officer Brown introduced himself, and told committee that he is a 20 year police veteran from the Northside District.

-12 detectives are working on the downtown murders. He can not discuss the specifics of the investigations. Many cops are taking these murders very personally. Probation and parole violations have led to some recent arrests.

-Eli Judge has noticed a change in students behavior and that they are now less apt to walk alone downtown now.

-Students living downtown should be locking their doors and windows, but many do not. The burglary task force is trying to emphasis that everyone lock their doors and windows.

The Burglary Report has grown from 5 to 17 pages recently. There would be a 40% reduction in burglaries in the downtown area if people would just lock their windows and doors.

-Lee said that some landlords are also making their downtown rental properties more secure. -Mufflin Street block party coming up on May 3rd, and police preparations are taking place

now. Police having pre-party meetings with students and student organizations.

-The Mufflin Street event has not been much of a problem in the past. Students like having their picture taken with the police.

-Downtown armed robberies are way down from last year.

C. Mall/Concourse Maintenance (Jim Weinstock & Joy Kummerow)

-The Pansy flowers have been planted.

-Joy will be gone using up comp time and vacation time, and not back until our August DCC meeting.

-Expansion of storage space, near the back of their existing facility will be going to the Board of Estimates (BOE) and is still empty. The Police Dept. is also requesting this space.

B. Downtown Planning (Bill Fruhling)

-Recent visioning session had about 80 people in attendance. Open house to start, then the Mayor spoke, Bill Fruhling spoke, Mark Olinger spoke and all highlighted the Downtown Plan and the 2020 plan.

-Then they broke into small groups to study the Downtown Advisory Report and asked people of their definition of downtown.

-The Plan is available on the web at www.cityofmadison.com/downtownplan.

-Some of the sections of the plan that were discussed included the following:

1) Sustainability- Land Use and Transportation.

2) Live/Work/Opportunities-for downtown area other than students and empty nesters.

3) Housing-more housing opportunities, discussions about price points.

4) Transportation-reduce single transit options, and the water/ice taxi.

5) Economic Development-the need for more downtown retail businesses to meet the needs

of downtown residents, and downtown jobs. (tied for 1st in votes as priority).

6) Cultural-new library downtown got a lot of attention. (tied for 1st in votes as priority).

7) Parks and Recreation-increasing downtown lake access.

8) Downtown Parks-more focus on urban open spaces.

9) Schools-some discussion of downtown schools and day cares.

10) Historic Preservation-some discussion.

-Planning Division is still taking comments from people in case they could not make the meeting.

-E. Washington Ave build discussion and maybe the downtown is expanding in this direction. -Fruhling said all land use plans are very specific. There has not been a Downtown Plan for

20 years. Neighborhood Plans are recent and good solid plans.

-The next steps:

Phase 1-background, starting point through May

Phase 2-concepts developed, start in April and go through the summer.

Final cutoff for planning process is April 2009.

-Zellers said that the Downtown Plan needs to be completed, and then feed into the zoning rewrite.
