COMP GROUP	DESCRIPTION
11	Those classifications in the Police Department which are formally recognized as comprising the bargaining unit represented by the Madison Professional Police Officers Association (MPPOA)
12	Those classifications in the Police Department which are formally recognized as comprising the organized unit represented by the Association of Madison Police Supervisors (AMPS)
13	Those classifications in the Fire Department which are formally recognized as comprising the bargaining unit represented by Fire Fighters Local 311
14	Those supervisory classifications in the Fire Department which are formally recognized as comprising the organized unit represented by the Association of Madison Fire Supervisors (AMFS)
15	Those classifications which are formally recognized as comprising the bargaining unit represented by City Employees No. 236 (Laborers International Union of North American, AFL-CIO)(Engineering, Streets, Motor Equipment, Library)
16	Those classifications which are formally recognized as comprising the general bargaining unit of City Employees Local 60 (AFSCME, AFL-CIO).
17	Those clerical or paraprofessional classifications which are confidential and/or supervisory in City government that are non-represented.
18	All authorized positions whose classifications are recognized as being professional, supervisory, and/or administrative/managerial and are non-represented.
19	Those non-civil service classifications which are salaried or have variable rates of pay. (includes Stagehands)
20	Those classifications which are formally recognized as comprising the clerical/paraprofessional bargaining unit of City Employees Local 60 (AFSCME, AFL-CIO).
21	All classifications which are recognized as comprising the managerial compensation group (all Division and Department heads).
22	Those professional classifications in the Health Department which are formally recognized as comprising the bargaining unit represented by the United Professionals for Quality Health Care (UPQHC).
23	City Attorneys that are represented by Madison City Attorney's Association (MCAA).
32	Those classifications in the Library Unit which are formally recognized as comprising the clerical bargaining unit of City Employees Local 60

	(AFSCME, AFL-CIO).
33	Those classifications in the Library Unit which are formally recognized as comprising the professional librarian bargaining unit represented by City Employees Local 60 (AFSCME, AFL-CIO).
41	Those operations classifications in the Transit Unit which are formally recognized as comprising the general bargaining unit of Teamsters Local 695.
42	Those clerical and paraprofessional classifications in the Transit Unit which are formally recognized as comprising the office bargaining unit of Teamsters Local 695.
44	Those professional and/or supervisory classifications in the Transit Unit which are non-represented.
