The City issued an RFP for design services for the replacement of the Badger Lift Station. A number of factors were considered, weighted, and scored for each of the proposals including project team and approach (40%), experience with similar projects (15%), cost (40%), and the City's standard local contractor preference (5%). With cost factored into the overall total score for each of the proposals submitted, MSA had the highest score, and as such, are being recommended for this design contract for the estimated amount of \$98,780.

As part of the Village at Autumn Lake Replat, Outlot 64 was dedicated to the Public for Stormwater Management and Drainage. The Developer, VAL, LLC, is responsible for the construction of stormwater management improvements within the outlot. The plan and contract was approved on December 13, 2024 by RES-24-00711, File No: 86065. Additional invasive tree removals are requested by the City for an area outside of the 75-foot drainage and stabilization limits for ecological restoration prior to the sale of lots adjacent to Outlot 64. The reimbursement up to \$25,000 for additional tree removals is the State Statutory Limit for reimbursement. Reimbursement shall be made payable to the Developer upon the City's acceptance of the Storm Greenway Improvements and project finalization.

This contract is for the construction of a dedicated public drop-off site at the Olin Ave Waste Transfer Station. Currently the temporary drop off site does not have a dedicated public drop off area. The current drop off area shares circulation space with the normal daily operations of the trash trucks coming to the transfer station to unload. To avoid the congestion and safety concerns with large trucks and public the temporary dop-off site has limited seasonal hours of a few afternoons/evenings and weekends. This project will provide a separate access road and circulation area to keep public traffic separate from city operations traffic. The project will also prepare the area behind the Water Utility Vehicle Barn for additional fleet vehicle parking. There will be an alternate bid item for finish paving and paint striping of the parking area. The total estimated cost of the project is \$2,350,000.

Additional trip hazards outside of the district 10 & 20 boundaries, typically reported by residents via the City's report-a-problem web site, will also be repaired as needed. The estimated cost is \$271,400.
