#### RESOLUTIONS APPROVING THE CONSTRUCTION OF PUBLIC WORKS PROJECTS

38. Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Cannonball Path Phase 1 and Water Main - 2010, Contract No. 6133. (14th AD)

The path project is the first phase of a multi-year project to construct approximately four miles of paved, multi-use path, accommodating bikes, pedestrians and other non-motorized users, in the former Union Pacific Railroad corridor. The City of Madison acquired the rail corridor from Union Pacific Railroad in July 2008 under a Federal Rails-to –Trails agreement, which preserves the corridor for potential future rail use. Wisconsin Department of Natural Resources awarded the City a Stewardship Grant for half the purchase price, under their Stewardship Funds program, under which the City agrees to preserve the corridor for path and open space purposes.

Approximately 57% of the corridor lands lie in or adjacent to the City of Fitchburg. A Memorandum of Understanding between the two Cities regarding ownership of the corridor and cost sharing for acquisition, development and maintenance of the path was executed in March 2008. Portions of the corridor within or adjacent to Fitchburg were transferred to Fitchburg in December 2008. Under the Memorandum of Understanding, Fitchburg will be contributing a portion of the cost of the current project. But the exact amounts and terms have not been finalized, and this contribution is not reflected in the budget numbers provided.

Madison Water Utility is a partner in the project as they have plans to construct a new water main along most of the length of the corridor to increase service reliability in the Arbor Hills area. WDNR has granted approval for this use within the corridor and the Utility has acquired an easement from the Cities of Madison and Fitchburg for the line. Funds from the sale of the easement will be applied to the cost of path construction, but are not reflected in the budget numbers provided. The Utility is currently constructing water main in the Phase 2 segment of the overall project, west of the current project under a separate contract let in 2009. Water main will be installed Phase 1 portion of the corridor as part of the current proposed contract.

The Phase 1 project consists of a 10-foot wide paved mainline path beginning at the west line of Arbor Hills and continuing approximately 1.1 miles to Greenway View. It includes approximately 0.35 miles of connecting paths linking the main path to the existing Capital City Trail, Westview Lane in Arbor Hills, Luann Lane in Leopold Park and the existing dead end of Greenway View. It includes construction of a new pre-fabricated steel bridge over a small stream, utilizing the existing abutments from the former railroad bridge.

The water main project consists of new 16-inch main along the entire length of the mainline path and 12-inch main extending from the main path to Westview Lane. It also includes replacement of existing 6-inch water main with 12-inch main in Westview Lane from Knollwood Park to Sandwood Way, and along Sandwood Way to the intersection of Grandview Boulevard.

Estimated Cost of this project is \$1,446,000. Report by City Engineering.
