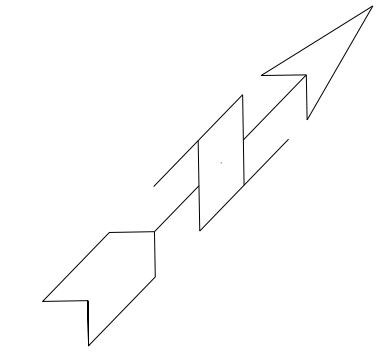
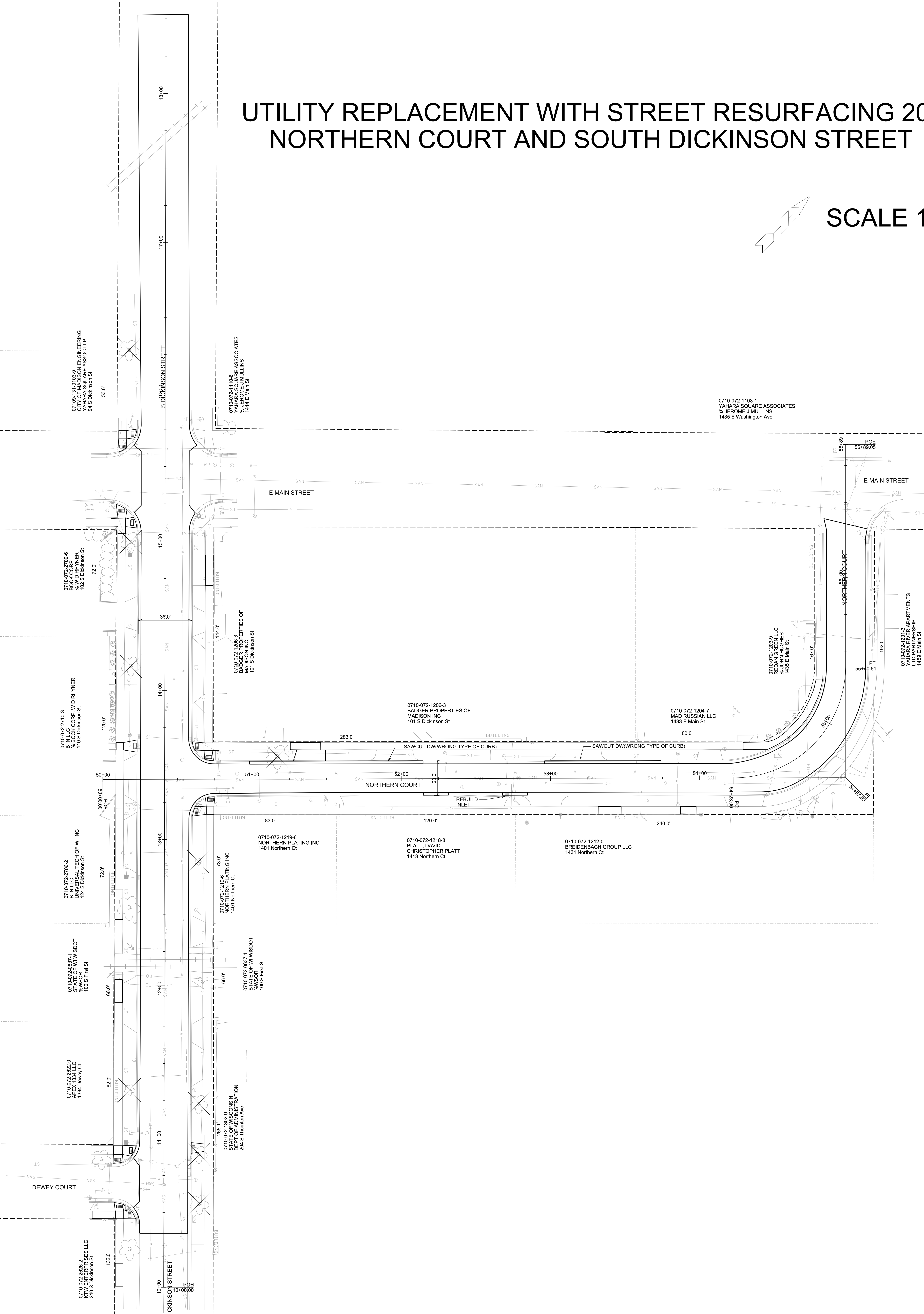


UTILITY REPLACEMENT WITH STREET RESURFACING 2016 NORTHERN COURT AND SOUTH DICKINSON STREET
