Hi Nashaly, Jose, and Andrew,

I wanted to provide more information on keeping the no overnight parking restriction on the 3800 block of Sycamore Avenue that we worked hard to receive in 2023. Attached is a photo of the 2023 petition for no overnight parking on Sycamore Avenue. These signatures are from the property owners at the time, and every property owner is still the same today except for one. I was the person who went around collecting signatures. Our neighborhood association president has the hard copy of this petition that was submitted to the city in 2023 when we received no overnight parking signs on the 3800 block due to overwhelming support (no parking 10pm-8am). My request is specific to the 3800 block as we were the only block who moved forward with the parking restriction. There are 13 addresses on the 3800 block of Sycamore. 10 properties but 3 of them are duplexes for a total of 13 addresses. As you can see on the petition, 12 of the 13 addresses on the 3800 block of Sycamore voted in favor of no overnight parking. Being that 11 of the 12 voters in favor are still property owners on Sycamore Avenue, the 3800 block is still nearly 100% in favor of no overnight parking, if not 100% at this point after neighbors realized how great of a change this was. It has been the biggest improvement to our street in the past decade that I've lived on Sycamore. If option A is chosen for Sycamore Avenue, no

further action is needed. But in case option B or C get chosen for Sycamore Avenue, please incorporate no overnight parking into the plans for options B and C as the petition from just recently in 2023 overwhelming displays support. Our street has been incredibly peaceful in the overnight hours since the implementation of this parking restriction. I have personally spoke with almost every neighbor on the petition recently and they all love the no overnight parking and would hate to go back to the noisy way our street was at night prior to 2023. Thanks so much for considering this. It's already a restriction in place for the 3800 block and we'd just love to keep it.

Thank you much for the info. I reached out to the transportation commission email today regarding the sidewalks. I've actually got one more thing I'd like to mention to you both. Currently on the 3800 block of Sycamore Avenue, there is no overnight parking from 10pm-8am. Our street voted on this a couple years ago and we worked very hard to get this no overnight parking put into place. I cannot tell from the presentation if this would still be in place for options B or C for Sycamore Avenue. Basically if overnight parking is allowed, our street gets literally flooded with residents and guests of the two apartment complexes at the end of MacArthur Road. The streets get very noisy overnight with people constantly coming, going, and loitering. Once our vote passed and made Sycamore Avenue get no overnight parking signs, it was such a nice improvement for the residents that actually live on Sycamore Avenue to be able to

have a peaceful street overnight. Please consider factoring in no overnight parking on Sycamore Avenue for Options B and C. Or of course Option A would already have this factored in so would also work well. We voted on this a couple years ago, the vote passed, and the city gave us "no parking 10pm-8am" signs. We'd hate to go backwards by no longer having these signs if they're not included with Options B or C. It was the best improvement we've had in years to have a more peaceful street in the overnight hours.
