Dear Ms. Robinson:

Your variance to Section 29.19 of the Madison General Ordinances has been reviewed.

The rule requires through the adoption of ILHR 21.04 that the stair width be 36 inches, headroom 6'4" and that stairs have a maximum rise of 8 inches and a minimum tread of 9 inches. The variance requested is to allow stair width of 33 inches and headroom of 6'8'. In addition, the treads are 8 inches rather than 9 inches.

Considered were your statements:

- 1. The stairway width cannot be easily changed.
- 2. Hardwired interconnected smoke detectors will be provided.

The following comments/observations were made in review:

- 1. This is a non Fire Department issue.
- 2. The Building Inspection Department supports the variance.
- 3. In reviewing previous action of the Board of Building Code, Fire Code and Licensing Appeals, we find precedence has been set at least five times in the past: 1826 Packers Avenue, 1717 Winchester Street, 3518 Wyota Avenue, 1801 Rowley Avenue and 305 West Sunset Court.

RECOMMENDATION:

CONDITIONAL APPROVAL

The conditions of approval are:

- Provide hardwired interconnected smoke detectors on all levels.
- 2. Provide/maintain handrails on both sides of the stairway.
- 3. Remove the cabinets at the landing so the width is 33 inches.
