At the hearing, you will have the right to represent yourself or be represented by an attorney of your choice, the right to present evidence, call witnesses on your behalf, and question and cross-examine witnesses. All testimony will be recorded by audiotape. Rules of Procedure for the Hearing are available at the Department of Planning and Community and Economic Development. After the hearing, the VOC will make a recommendation to the Common Council regarding your license. The final decision will be made by the Common Council at a future meeting.

I. VIOLATIONS OF THE LAW, SUBSTANTIALLY RELATED TO VENDING:

Date of Violation: 5-25-08. Charges:

(A) State of Wisconsin v. Jeff A. Okafo, Case No. 08-CM-1675
Resisting a Police Officer, Wis. Stat. ss. 946.41(1), 939.51(3)(a)
Class A Misdemeanor

(B) <u>City of Madison v. Jeff A. Okafo</u>, Case No. 08-MOR-6053 Disorderly Conduct, MGO 24.02(1) non-criminal municipal ordinance violation

Summary: Jeff A. Okafo was arrested for Resisting an Officer after a physical altercation with a Madison Police Officer on May 25, 2008, at 21:06 hours, in the 400 block of N. Frances Street in the late-night vending area where Okafo does the majority of his business. A Madison Parking Enforcement Officer was attempting to ticket Okafo's truck for parking an Unregistered Vehicle on the street, and to have it towed for violating the City's parking "scofflaw" policy (all vehicles with \$250 or more unpaid parking citations are to be towed and impounded if found illegally parked on the street.) The parking officer called for police back-up, Okafo made verbal and physical threats to both the Parking and Police Officers, did not cooperate with police requests, a physical altercation ensued, Okafo was arrested and charged with Resisting a Police Officer.

(C) State of Wisconsin v. Jeff A. Okafo, Case No 08-CT-1126 Operate Motor Vehicle After Revocation - 4th/Subsequent offense, Wis. Stats. 343.44(1)(b) and (2)(b), Misdemeanor Traffic offense

Summary: Jeff A. Okafo was arrested for Operating a Motor Vehicle After Revocation by the Fitchburg Police department on March 31, 2008 while driving his 1997 Dodge Ram Truck, the vehicle used to pull the vending trailer. He was charged with 9th Offense Operating with a Revoked Driver's license. This violation is substantially related to vending because Mr. Okafo must drive his vending cart to and from the vending site, and is known to use this truck for that purpose. According to DOT records, Okafo's Wisconsin drivers license has been revoked since approximately early 2004, would have been revoked on the date of the police altercation (May 25, 2008) and during all times of the parking tickets described below. Therefore it appears Okafo has been driving to and from the vending site with a revoked drivers license, contrary to City ordinance and State law, MGO 12.011, Wis. Stat. sec. 343.44(1)(b) and (2)(b).

C. The parking tickets listed in paragraphs A. and B. are serious and repeated violations of Chapter 12 of the Madison General Ordinances.

The frequency of parking tickets indicates lack of respect for the laws of the City of Madison. Licensed Street Vendors should not routinely violate the law as part of doing business.
