PUBLIC NOTICE

AT&T will be extending its fiber optic network within the City of Madison during the next few months, February through June 2008. This work is being done in order to enhance existing facilities in the Madison Area.

There will be a public hearing on this project on February 20, 2008 at 6:30 p.m. Room 201 of the City-County Building, 210 Martin Luther King Jr. Blvd., Madison, WI.

Cable installation contractors hired by AT&T will install buried fiber optic cable within the roadway limits at the following locations:

1. Along Lake Point Dr. from the intersection of Bridge Rd. west to Fayette Ave., then south on Fayette Av. To Frazier Av., then west on Frazier Av to 407' west of the intersection of Raywood Av.
2. Parkside Dr. from the intersection of E. Washington Av. North on Parkside Dr. approximately 450' then north on Portage Rd. to the intersection of Portage Rd. and Clove Dr., approximately 4,400' then south on Clove Dr. approximately 85'. A new cabinet will be placed in the utility easement at 3102 Clove Dr.
3. At the intersection of Aberg Av and Crowley Av go north to the intersection of Crowley Av and Boyd Av., then west on Boyd Av., to Sherman Av.; north on Sherman Av., until the intersection of N. Sherman Av., and Trailsway then west for approximately 130'.
4. Mifflin St and Few St., starting from approximately 75' east of the intersection of E Mifflin St and N Ingersoll St going east on E Mifflin St for approximately 680' then head north on N. Few St. for approximately 1,109' which is just past the intersection of N. Few St. and E. Gorham St.
5. Raymond Rd starting at approximately 453' west of the intersection of Canterbury Rd and Raymond Rd going west on Raymond Rd. for 1,370 ', then crossing Raymond Rd to the south side, going east for approximately 80' to the intersection of Raymond Rd and Muir Field Rd., then south on Muir Field Rd for 855'; then cable is placed in a utility easement running southwest along the rear lot lines of Pagham Dr and between Scenic Ridge Dr. and Turnberry Rd to Gladstone Dr., crossing Gladstone Dr., into a utility easement from Gladstone to Corona Ct in the rear lot lines.
6. Old Middleton Road from the intersection of burying cable from Whitney Way going west 265' ;the cable with then go aerial for 1,546', then continuing west for 894' to 145' west of the intersection of Englewood Dr. and Old Middleton Rd.

Restoration of any damage within the limits of the road right-of-way will be completed in accordance with the City of Madison's standard specifications. All damaged sidewalk slabs will be replaced with 5' lift concrete. All damage done to grass between sidewalk and curb will be restored with a four inch covering of black dirt and seed. All restoration required within the traveled portion of the roadway will also be completed in accordance with the City of Madison's standard specification.
