The NTMP Objectives, Policies and Procedures are attached. The document

has been modified to relax selection criteria and steps for disadvantage areas/neighborhoods. The changes were made in consultation with the City racial equity team. Recommendations include changes to item number 8, page 3, noting the following:

“In the interest of furthering racial equity and access to the NTMP by neighborhoods with residents who have historically not been involved in City processes the City may waive &/or modify the petition and survey requirements in consultation with the District Alderperson. These neighborhoods are typically areas with higher concentrations of low income residents, people of color or within Neighborhood Resource Team areas.”

Page 5, Step 3 has also been modified, and provides “The City may consider other compelling issues to determine project priority and scheduling.”

These changes are in addition to work being done with City Information Services to consider new ways to encourage participation, including mechanisms to survey people electronically for example via cell phone. This is to encourage greater participation in the process and should benefit all neighborhoods.
