Neighborhood Traffic Management Program (NTMP) Revisions Approval.

Foster moved to accept the Neighborhood Traffic Management Program (NTMP) Revisions; Zellers seconded.

After much discussion, the commission made the following amendments:

- Sentence on Page 5, Step 3- changed to read: "The City may consider racial equity, social justice and other compelling issues to determine project priority and scheduling."
- Page 14, the last sentence changed to read: "The point total is considered along with using the Racial Equity and Social Justice tool and other information when determining the priority of a project."

Rewey requested administratively, the staff add a footnote, mentioning the 'Racial Equity & Social Justice Fast Track Tool' as the tool being discussed in the NTMP Document.

Lewandowski moved to put the ammendments to a vote. The motion passed by voice vote/other.

Foster requested the verbage on page 2, under "Objectives" be altered to replace the word, "vehicular" with "motor vehicle." The motion by Grant, was seconded by Kemble.
