## Security Plan:

To whom it may concern,

I plan to host live acoustic artists, art shows, fashion shows and poetry nights at faded kitchen. I plan to manage and control crowds by having artist play only as dinner shows. All guest will be seated at tables and served a meals by waitresses as they watch the artists. I plan to hire and have on premise two security personnel for each night that we plan to have artist shows. The security will be there to monitor the parking lot and to inform guest of patio close time since the patio will close before the restaurant each night.

As for the bar I plan to have each waitress and bartender be trained and holding a valid servers certification through the Learn2serve website. So that they will know exactly how to check ID's, notice if ID's have been tampered with and how to spot signs of intoxication. Each guest will be ID'ed separately when ordering any alcoholic beverages with their meals. I plan to keep the dinner shows orderly and well maintained because our shows will be in a restaurant setting; there will be no dance floor and no sit down bar. All guest will be seated at dinner tables enjoying a meal and show.

When I get to the step of hiring employees and security personnel, I plan for all waitresses, bartenders and cooks to wear the same Faded Kitchen T-shirts and aprons. As for the Security personnel I plan to have them dressed in black Faded Kitchen T-shirts as well but their shirts will say security across the back in reflective tape so they will be seen even when it is dark outside.

Lastly I will make sure no one of any age is roaming the premise during any artists show or art display. I plan to control that again by only holding artists shows inside the restaurant, with each show being merely a dinner show. There will be no wandering around or hanging out in the parking lot because each guest will be seated at a dinner table and served by a waitress keeping traffic low and uncluttered.
