Facilities Report

Mark Benno reported that at Central the robocleaner is doing a fantastic job and they are looking into getting a companion scrubber, as the robocleaner is a solely a vacuum. Also at Central the mock-up lighting is going in next week, once it is installed the board members will be alerted so they can review the sample. City Engineering is putting out an RFP for water incursion repairs at the Library Support Center. The construction around Goodman South Madison is wrapping up, the parking lot and green spaces should be done soon. At the Pinney circ desk a pass through is being planned to ease access from the desk to the front door. There is also work planned on the play lab and the HVAC.

Foundation Report

Conor Moran reported that during the Wisconsin Book Festival 52 events brought 3200 people into Central and throughout the year 6,000 people came to Central for WBF events, which doesn't include offsite events. Ex Libris is November 7 and has already raised over \$100,000. The Imagination Center Library fundraising has been successful this fall with \$250k from a private donor and another \$500k pledged.

South Central Library System Report

Gen Carter reported that SCLS is working on a system plan which she will share once it is public.
