# **Meeting Minutes - Approved** TRANSPORTATION COMMISSION

#### **CALL TO ORDER / ROLL CALL** A.

Kovich informed the Commission that the Council confirmed Kliems' appointment which will be effective once the Mayor signs the Council report.

#### F. **NEW BUSINESS**

F.1. 57605 Amending Section 11.06(4)(g) of the Madison General Ordinances to allow a license transfer with the approval of the City Traffic Engineer.

Foster moved to RECOMMEND TO COUNCIL WITH THE FOLLOWING RECOMMENDATIONS - REPORT OF OFFICER, with a note to Refer to Transportation Policy and Planning Board as they are the sole referral for this item, seconded by Streit. With no further discussion, the motion passed by voice vote/other.

F.2. **57513** To Approve 2020 Transportation Commission Meeting Schedule Streit moved to approve, seconded by Bremer. With no further discussion, the motion passed by voice vote/other.

F.3. 57753 To Approve Quarterly Update of TC Annual Work Plan

There is some concern over the utility of a Quarterly Traffic Safety Report as it has been presented in the past, and discussion of the possibility of Traffic Data being selected for safety aspects pertinent to the purview of the Commission. Brown suggested a subcommittee be created to clarify the issue. It was agreed by the Commission that it was interested in receiving the next Quarterly Traffic Safety Report; and when preparing the next quarterly report, Traffic Engineering continue to meet with Police, review the data collected and determine how to present it to reflect the Commission's concerns. Streit asked about the possibility of shifting quarterly tasks so the Commission's workload may be spread more equally during the year.

### G. INFORMATIONAL PRESENTATIONS

G.1. 57512 Training on the Toolkit of Options for Traffic Safety

Assistant City Traffic Engineer Brian Smith provided verbal reports on the Toolkit of Options for Traffic Safety and, along with City Transportation Director Tom Lynch, was available for questions. Clarification is needed on the distinction between the Neighborhood Traffic Management Program and other traffic safety tools, as well as the approval process and school zone speed limits. Foster suggested adding street narrowing, traffic circles & medians, verticle edge treatments (trees and plantings), diverters or restrictions to limit amount of traffic, pavement texture, paint, tightening turning radiuses, reducing number of traffic lanes, different crosswalk treatments. Add speed tables and remove the section on Pedestrian Safety tips. There was a question whether the City has a policy on accommodating bicycles in school zones. After much discussion the Commission asked that the updated Toolkit be presented again to the TC after revisions have been made.
