# **RESPONSE TO REQUEST FOR ADDITIONAL INFORMATION**

## 1) Summary of NPC Accomplishments in 2007-08

2007- January to December

- Organized an extensive **2007 Schools Campaign** in partnership with the East Attendance Area PTO Coalition which included:
  - A community mobilization in spring 2007 that helped defeat a district proposal to close Lindbergh Elementary School;
  - Intensive leadership training through weekly campaign meetings and individual mentoring with a core team of 4-6 leaders;
  - Over 20 house meetings in August and September involving over 100 people
  - A Community Roundtable September 27 attended by over 30 people
  - Individual meetings with each of the seven School Board members
  - A District-wide Forum on October 21 with six School Board members present
- Effectively moved the School Board to begin taking action on a long overdue **equity policy** (finally adopted in 2008), in addition to preventing the closure of Lindbergh School.
- Conducted the 2007 Northside Consumer Questionnaire, completed by 565 people.
- Continued to work to aid Pierce's Northside Market the Northside's anchor business.
- Provided extensive input to the **Northside Walking Audit** to correct barriers to walking and biking on the Northside.
- Addressed safety issues and assisted in the eventual sale of the troubled **Woodlands and Woodland Park Apartment** complexes.
- Engaged in an ongoing dialogue about actual and perceived crime and safety issues.
- Conducted an intensive six-week Leadership Circle for seven emerging Northside leaders.
- Mentored neighborhood leaders organizing and revitalizing three **neighborhood associations**.
- Held four candidate forums for City Council and School Board races.
- Produced six issues of the *Northside News* with over 30 volunteer writers and photographers who receive related newspaper training as well. Our newspaper, the *Northside News*, continues to be the "voice of the Northside" in its community building capacities.
- Produced the first annual edition of the Northside History Calendar, a fundraising success.
- Organized the 5<sup>th</sup> Annual North Star Awards attended by over 125 people.

## 2008- January to July

- Successfully organized against proposed cuts to Northside Metro bus service.
- Negotiated a community agreement for the Tennyson Terrace development.
- Celebrated the School district adoption of an equity policy NPC helped develop & advocate.
- Began developing & promoting an initial vision/concept for Northside economic development.
- Organized a forum on the City's proposed **Economic Development Plan** held on March 10 attended by over 20 people.
- Provided detailed input to the City's Economic Development Plan.
- Successfully advocated for the unification of the two Northside Neighborhood Plan areas and expansion of the project timeline.
- Initiated work with the **Northside Neighborhood Plan** Steering Committee to increase community input in the plan.
- Assisted the East Attendance Area PTO Coalition in meetings with each of the two candidates for **School Board**, which were uncontested elections.

- Held two half-day training retreats attended by 27 leaders.
- Assisted Berkley Oaks Neighborhood Association with response to development proposal.
- Organized a delegation to meet with the **new Police Captain** for the North Police District.
- Provided extensive feedback to the City's Neighborhood Indicators Project.
- Held two candidate forums for the County Board races.
- Initiated a mediated dialogue between three Northside neighborhood/community organizations about a proposed **community building at Troy Gardens**.
- Initiated a 15th Anniversary Campaign to raise funds and build relationships.
- Submitted our 2009-10 Consolidated Application.
- Produced three issues of the *Northside News* with over 30 volunteer writers and photographers who receive related newspaper training as well.
- Expanded membership in the NorthsideDiscuss E-List.

### 2) **Diversity of NPC's membership (minority representation)**

Of NPC's current thirty-five members (board including alternates), seven (20%) represent racial or ethnic minorities (4 black, 2 Asian, 1 Hispanic). This makeup is generally reflective of the demographics of the Northside community, which is 83% white according to 2000 Census figures.

Perhaps in relation to this question, NPC leaders providing testimony on 7/29 also reported being asked by a Commission member "Why, if NPC trains and involves so many leaders, do the same NPC leaders seem to appear before the Commission?" According to our count, ten different NPC members have attended Community Services Commission meetings over the past two years, although not all spoke. NPC has tended to draw on its six member Executive Committee to provide primary testimony before the Commission, because those individuals are best acquainted with the overall work of the organization and its finances. If the Commission would prefer to see more or different leaders appear before the Commission, NPC would be happy to organize such a delegation.

#### 3) Summary of Financial Resources Mobilized
