1. Type of Live entertainment being offered and number of security personnel:

- A. First Friday of the month "Indulge your Senses" with Rotating Art Reception with local artists playing chill bass music starting at 9PM ending at Midnight.
- B. First Saturday of the Month "Mideast Salsa" with dance lessons starting at 8pm followed by live salsa, bachata, merengue music ending at 10PM.
- C. Third Friday of the month "Oudist Colony and Jeff & Ana Paula" starting at 8:30PM with belly dancing and live middle eastern music followed by live Brazilian guitar and singer ending at Midnight.
