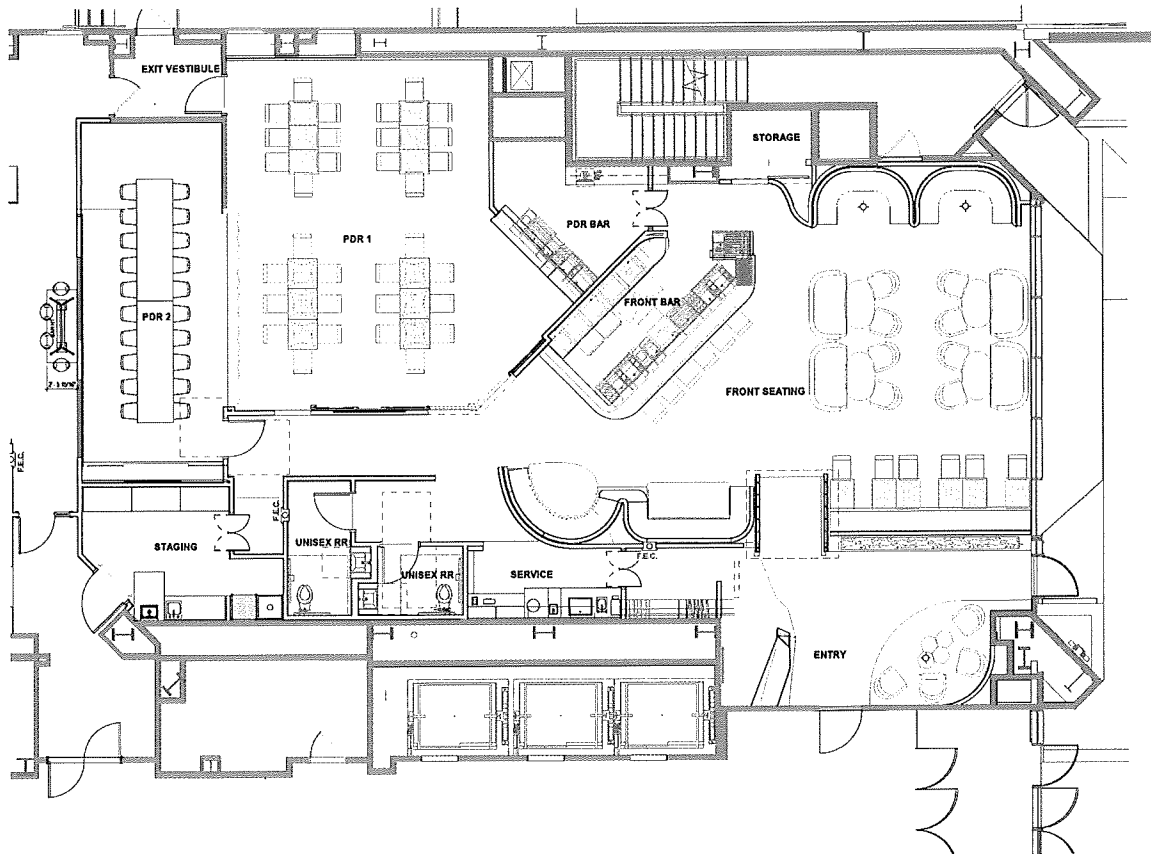

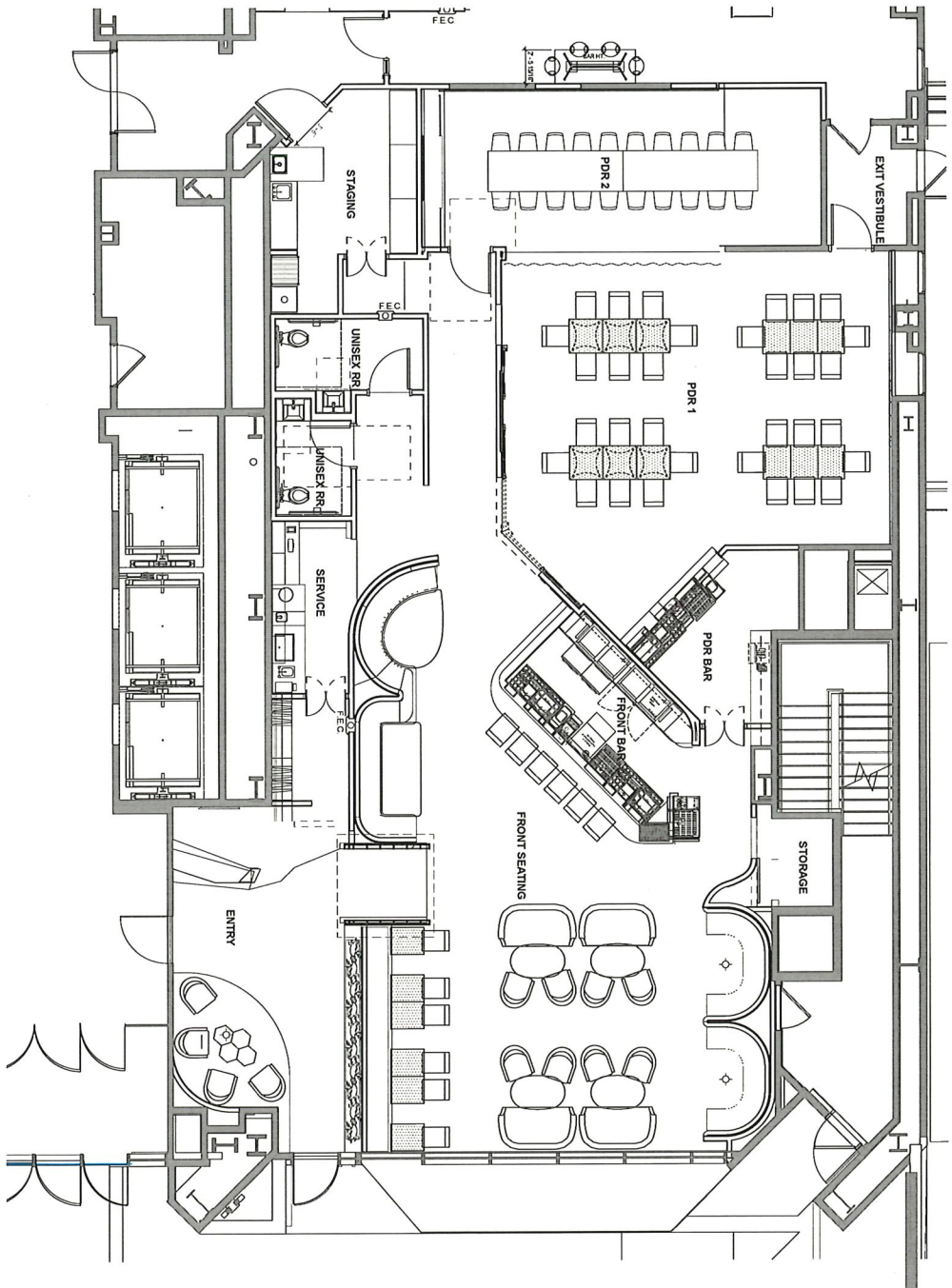

The expansion project consists of four primary areas:

| Area | Description | Size |
|--------------------------------------|--|----------|
| Main Dining Area | Functions as a replacement to sixth floor expansion dining space for regular diners, with primary utilization on busier nights. Aprox. 55 seats | 3,651 sf |
| Bar | Addition of a new, secondary, bar to provide beverages to the new expansion space and supplement bar capacity for the outdoor patio on an as-needed basis. | |
| Private Dining Room (PDR 2) - Small | Serving up to group sizes of 20, this space will be primarily intended for smaller special events. | |
| Private Dining Room (PDR 1) - Large | Serving up to group sizes of 40, this space will be primarily intended for larger special events. | |



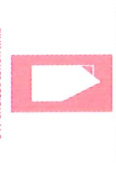


1 FIRST FLOOR PLAN, SUITE 125, ALRC

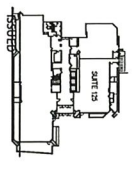
