#### **DISCUSSION ITEMS**

13906 Update of Building a Green Capital City Plan

Sherrie Gruder told the committee that a working group met to discuss process. Sherrie asked Brian Joiner to facilitate the meetings for the next several months. Brian has worked with companies and facilitates many meetings. He is also involved with Sustain Dane and the City staff regarding the Natural Step.

Brian began talking about updating the Blueprint.

Sherrie has a worked up a draft for the work plan for rewriting the plan. Sherrie told the committee that there was a recent meeting with the Mayor. The Mayor is very pleased with the progress. He also wanted to make sure that we include or work with the Natural Step as the plan is rewritten.

Sherrie passed out a handout showing a draft work plan for rewriting the plan.

Sherrie mentioned that the first plan really does not deal with carbon or the concept of Zero Net Energy.

The handout shows four topics: Carbon and Zero Net Energy City Operations Private Sector: Polices and Initiatives Public Outreach

The Mayor did mention that the report could look the RTA and the environmental impacts of having a RTA.

Brian clarified the possible workgroups. Is there anything that should be added? Then the Committee provided thoughts on these topics.

CARBON AND ZERO NET ENERGY

Add definition of Zero Net Energy. Is it really possible? Consider the name. Clarify definition of Zero Net Energy and then make it clear that energy efficiency is a way to get there.

- Review City's Climate Protection Plan
- Research and Review Carbon Neutrality
- Consider a Goal for carbon.
- Be clear as to what we already have agreed to do and then decide if we want to go further

- What the State is doing in general for carbon etc, such as the Governor's Global Warming Task Force.

- Consider what the UW is pursuing carbon neutrality – energy efficiency, conservation, renewable energy – they are implementing.

#### **CITY OPERATIONS**

- Committee advocates for operating and capital funding to maintain and upgrades facilities and capital assets.

- Follow-up to make sure green budget is spent on green stuff.

- Planning Department a need for Sustainable Planning – Staffing increase/training

- Comprehensive Training of Maintenance Staff
- Develop Metrics something to look at so we know we are doing better in two years.
- Establishment of a baseline
- More emphasizes on greening the city fleet and transit
- Comprehensive Planning need to review in terms of sustainability
- Green preference to city purchases

#### PRIVATE SECTOR: POLICIES AND INITIATIVES

- Get education from the private sectors

- Getting at the disconnect between how project are developed and end user. Who pays and who benefits.

- Also the disconnect between developer and A/E firm
- Inspectors, Contractors, Developers
- Follow up to make sure that green budget is spent on green stuff

- Investigate and adopted a provision for 3rd parties energy efficiency and renewable

- Streamlining of permitting processes
- An awards program for the private sector

#### PUBLIC OUTREACH

- Significant public hearings listen to the public
- Publishing our energy consumption real time.
- Move meetings to various places throughout the city and invite the public in.
- Goals to be established.

- What other sustainability initiative are out there?
- Other things the committee members need to know common council
- procedures etc.

- Including in short term benefits for long term initiatives
