I'm writing regarding the special meeting to address parking and loading considerations at your special meeting session July 11.

One of the graphics is partially obscured on page 8 (it appears there is space for canopy trees in your diagram) and another graphic is familiar because it is the pyramid of priorities of the Complete Green Streets plan.

I live at W Wilson between Broom and Hamilton and I believe our street was designed with this new pyramid in mind: pedestrian safety, bike lanes separated from traffic and reduced lanes for cars with no on street parking. New canopy trees were planted in the terrace spaces this spring. It seems to be the perfect example of our priorities as a city. It accomplishes needed tree canopy in a warming climate, safer biking, and slower traffic.

The slide show attached to the agenda is curious to me as it seems like a plan/proposal or discussion that brings to the forefront a concern or set of concerns that address an unintended gap for deliveries. The graphic for the **downtown** space shows tree canopy as third on the list of priorities. For the sake of our climate and for a healthy urban community please consider carefully the impact on our urban landscape and the goal of a more robust and greater percentage of tree canopy what the unintended consequences might be in this proposed plan.
