NEW BUSINESS ITEMS

- 1. 483 Commerce Drive Raymond Del Ponte of Excel Engineering appealing Comm 715.5.3.1. Penetration of shaft enclosures. The variance requested is to waive the requirement for smoke dampers per the 2006 IBC which is in the adopting phase. The current rule allows the elimination of the fire damper if a sub-duct installation is used. The future code adds residential to the categories where the smoke damper can be eliminated. The Madison Fire Department supports the variance.
- 2. 6300 Enterprise Lane Mark Kruser of Kruser Architecture Inc. appealing Comm 705.6.1. The rule requires where a fire wall serves as an exterior wall for a building and separates buildings having different roof levels, such wall shall terminate at a point not less than 30 inches above the lower roof level, provided the exterior wall for a height of 15 feet above the lower roof is not less than 1-hour fire-resistance rated construction from both sides with openings protected by assemblies having a 3/4-hour fire protection rating. There is an existing wood framed overhanging eave of 2 feet and the drywall terminates at the bottom cord. The Madison Fire Department supports the variance provided sprinkler protection is provided at the eave of the taller building in accordance with NFPA 137.8 2007 Edition.
