 - * 2) License holder will work with neighbors on control and clearance of parking lot.
 - * 3) Live music will end by one hour before bar time Monday - Friday mornings, and half an hour before bar time on Saturday and Sunday mornings.
 - * 4) Front door will be closed whenever there is live music, and back door will be used as an entrance until 9 p.m., at which time door will be locked and used as an emergency exit only.
 - * 5) License holder will work with Waste Management to require no dumping before 7 a.m.
 - * 6) Bartending staff will be instructed not to dump waste between 9:00 p.m. and 10:00 a.m.
 - * 7) Bouncer will keep smoking patrons in front of the bar and away from adjacent housing.
 - * 8) License holder will require staff to attend the Safer Bars Training whenever it occurs.
 - * 9) Renewal is contingent upon review by the Alcohol License Review Committee.
 - * 10) Alcohol Licensed Establishment Response Team meetings will occur in January and April of 2006.
