I, Matthew Tye, being first duly sworn on oath, depose and say:

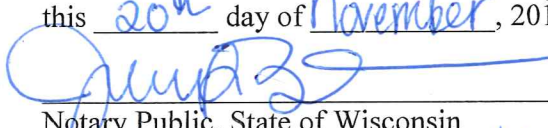
1. I make this affidavit based on personal knowledge.
2. I am the Patrol Lieutenant for the South Police District.
3. Divine Orders Catering LLC is located in the South Police District.
4. I make this affidavit in support of my request pursuant to Madison General Ordinance ("MGO") § 38.05(10(b), for an audit of Divine Orders Catering LLC, ("DOC") d/b/a Divine Orders Catering for purposes of determining whether DOC is operating as a restaurant as required by its alcohol license conditions.
5. I was inside DOC at 2122 Luann Lane, Thursday, November 15, 2018. At that time, I did not observe any food menus. I did observe a grease board that displayed several drink specials and another grease board that said something to the effect of "cook your own pizza" for \$5.
6. The advertising for DOC does not emphasize food and the nature of the advertisements suggest that DOC is a tavern or a club, not a restaurant.

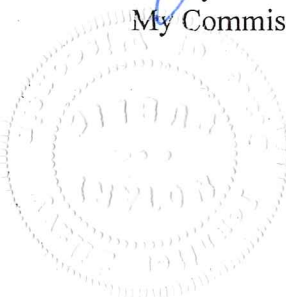
7. DOC has staff wand patrons for weapons at the front door at least on weekend nights.
8. The bar space, including the dance floor area, is much larger in square footage than the kitchen and food prep area.
9. The interior of DOC looks like a tavern or a club; it does not look like a restaurant.
10. The advertisements for DOC emphasize drink specials rather than food. At least one advertisement advertises, "Free tequila shots" and makes no mention of food. (Exhibits "A" and "B" and "C" (Attached).
11. Neighbors living near DOC have complained about loud music coming from DOC during evening hours.
12. DOC has a disproportionate number of calls for police services than other restaurants in the South Police District.
