- 4) The Common Council has 60 days (by approx. July 21) to adopt the final ward plan and list of polling places.
- 5) The Common Council has 60 days (by approx. September 21) to adopt the final aldermanic plan and the County Board has 60 days to adopt the final supervisory district plan.
