Letters of Intent are due via email by 4:30, April 13, 2012. Late letters will not be accepted. A Draft Request for Proposals (RFP) will be available in the CD Division, 215 Martin Luther King Jr. Blvd, Room 225, for review and comment. Pending approval by the CDBG Committee at its 4/5/12 meeting, the Final RFP will be posted on the website by 5/21/12. The City will contract with

one or more non-profit provider(s) to provide financial assistance and housing stabilization services to persons who meet HUD's definition of *homeless* and *at-risk of homelessness*. A total of \$121,645 will be available for this purpose.
