MALL/CONCOURSE FOOD VENDOR STATUS

New Food Cart Locations for M-Sat: Staff has met with the State Historical Museum and Grace Episcopal Church to secure new temporary locations for Monday-Friday along N. Carroll St. There will be space for three in front of the Museum and two in front of the church (with exception of Good Friday). The two spaces in front of Grace Episcopal Church will also be available on Saturday's.

Construction: Construction on the Square has begun as of 2/8/17. It is scheduled to last until late July or early August of 2017. It will go from W. Washington – S. Carroll St. – W. Main St. – E. Main St. – S. Pinckney St.

MLK Vending Sites due to construction: 8 carts will be located on MLK in front of the Madison Municipal Building M, T, TH and F due to construction. On Wed. they will be relocated on to E. Doty. The meter bags will be covered at the expense of the project. Vendors will incur no additional fees because of this move.

Saturday Food Court: I am working with Park and Traffic as well as Christine Ameigh from Let's Eat Out to secure a special events permit to allow for the food court on Saturday's. The planned location for this year's food court is on E. Mifflin St.
