# RESOLUTIONS APPROVING THE CONSTRUCTION OF PUBLIC WORKS PROJECTS

23. Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Edgewood Drive Resurfacing, Contract No. 6005. (10th AD)

This is a resurfacing project that involves milling and grinding the old pavement, base patching, and installing a new asphalt pavement. The pavement width varies, and averages approximately 14'. The new pavement will be 14' wide over the majority of the length, approximately 2,100', and less where that width cannot be attained. The work involves working very close to several Native American effigy mounds. The tree at the eastern end bisects the existing road. The southern side of the pavement around the tree will be removed and not replaced as it was installed by vandalism. The connection to Woodrow Street on the west end was cut off to motor vehicle traffic in 2006 in order to minimize traffic. Estimated cost of this project is \$140,000.
