I may have missed reviewing this the first time around. We should be aware that we have a concept plan for a Starkweather bike path extension from Anderson Street north to CV around the east perimeter of the airport, but we have not worked out any detailed plan for the route. I understand the airport need for security, but would like to consider having a bike path near the back edge of the unsecured public area. That would give the path an opportunity to avoid a lot of busy streets, and street / driveway crossings as it goes north.

As it pertains to Shaw St. vacation this could mean that we might someday want a path somewhere near the sewer line where the fence is proposed. It looks like the vacation resolution allows us to get anything up to a public street in the future, but I wanted to express specific support for some kind of a bike path that would be compatible with the airport's future plans.
