Application for Entertainment License Security Plan

- 1. Pooley's will offer live music on the patio on Friday and Saturday evenings to entertain guests while dining. We will also have live concerts inside the Field House area 3-4 times per year. We have 4-6 Security personnel for concerts to check ID's, monitor parking lot, and maintain control.
- 2. The parking lot will be monitored by management during smaller events and security personnel during larger events. Security personnel will be checking ID's at the front door and refuse entry to anyone intoxicated or presenting false ID. False ID's will be confiscated by security or management. Any unruly patrons shall be observed by security or management to determine best course of action. Patron will be asked to leave, and police contacted only if patron cannot be removed. Intoxicated patrons will be offered non-alcoholic beverages and fatty foods. We will attempt to enlist patron's friends to assist in the process of refusing alcohol service. If the patron becomes unruly he will be asked to leave and offered a cab.
