

To the Plan Commission:

I attended a neighborhood meeting this week led by Kirk Bangstad, the owner of Minocqua Brewing Company (MBC). Mr. Bangstad is requesting a conditional use permit for amplified music in the small garden area located behind his bar just down the street from our home at 226 Oak Street.

I joined the public meeting with a scattering of information and background, and willing to give the situation and Mr. Bangstad's request the benefit of the doubt. Kirk presented himself both as a musical 'expert' and as an innocent, guileless business owner prepared to positively address his neighbors' concerns. He opened his presentation by subjecting us to a jilted, off-key, operatically-loud performance of Danny Boy, and from there proceeded for an hour to demean an entire neighborhood while posturing himself as the aesthetic saviour to us poor, broken souls here on Oak Street.

After attending the presentation, there's no way I can support his request, and I urge the Plan Commission to deny it. It's obvious that he'll resist any effort to control poor behavior by his customers, and equally obvious that any effort the neighbors might have to expend to address inevitable non-compliance will be met with hostility and aggression. He presented himself as a guy who takes a mile or even two, when given an inch.

Mr. Bangstad also presented an obvious lie, that the Air National Guard F-35s fly over "every day." That's simply not true, and I wish I had called him on that at Monday's public meeting. He's just trying to paint this image of Oak Street as a poverty stricken hellhole slathered in excess noise. Don't believe it, not even for a second. We've lived here at 226 Oak since 2003, and have always been pleasantly surprised at how quiet it actually is, given its location between two of the major commercial corridors in Madison.

Our family has been heading up to Minocqua in Oneida County, home to MBC's original location, since I was a child, so I knew Kirk's reputation well before he came to Madison. Even there, I was willing to give him the benefit of the doubt. But no more -- after seeing how he presented himself and described himself as "at war" with the municipalities in northern Wisconsin, we can entirely expect similar behavior here. Mr. Bangstad isn't under attack for his self-described progressive values -- instead, he strikes me as combative, petulant man who relishes posturing himself as the victim of people who just can't recognize the genius he so desperately wants to share with the world, whether or not the world wants what he has to offer.

For the sake of our neighborhood and neighbors, I urge the Plan Commission to deny Mr. Bangstad's request for a CUP.
