Subject: Opposing Fireworks at Mallards Games

City of Madison Parks Commission,

I strongly oppose the fireworks shows at the Mallards stadium for the following reasons:

The Mallards baseball team is enjoyed by all ages and is a major attraction for Madison's north side. Because the Mallards stadium is located in Warner Park as well as adjacent sports fields and the community recreation center, it is in close proximity to the natural park areas that host a wide variety of wildlife that is directly impacted by the fireworks shows that occur after the games end. Specifically, I'm concerned about the effect the loud, explosive fireworks shows have on the nesting bald eagles and their eaglets.

Although bald eagles have made an impressive comeback from the brink of extinction and are residents of Warner Park, they are now facing a dire threat from the avian influenza H5N1 strain that has already killed at least 606 bald eagles in 45 states as of 2022, but this is considered a small fraction of the total number of bald eagles that most likely died from the avian flu strain that year.

In addition, the effects of avian flu on nesting eagles in Wisconsin was also catastrophic in 2022 resulting in 65% of occupied bald eagle nests failing to produce a fledgling eaglet, including an eaglet in Warner Park.

Although nesting sites in 2024 resulted in fledged eaglets, bald eagles deserve our protection to maintain a thriving population to counteract potential effects of future avian flu outbreaks. Loud fireworks displays can negatively impact bald eagles and other bird species by causing adult birds to panic and fly away leaving behind nesting chicks as well as flying into buildings and other obstacles. Nesting chicks of all bird species can panic and leap out of the nest and die as well, which was also a concern for this year's nesting eaglets.

Drone light shows are an alternative to explosive, noisy fireworks displays and should be encouraged considering the proximity of the display to the natural park areas.

In response to the Mallards' Neighborhood Impact Plan for 2024:

Thank you to the Mallards for installing a state of the art sound system.

Launching the fireworks from the football field adjacent to the stadium to create a "larger distance from potential environmental concerns" is a false narrative. It only moves the launch site to an area that hosts local children from East high school and the Latino Soccer League and their families. The debris that is left behind such as particulates, chemicals and heavy metals are still on the ground and will be disturbed with the field use as well as washed into our watershed. If we want to prevent high levels of pollutants from our lakes and watershed, then no fireworks is the best option.

The launch site is still within ½ mile of an active breeding pair of bald eagles. This pair arrived during the calm of the pandemic and it was the first time in the history of Warner Park to host a bald

eagle nest. US Fish & Wildlife regulations related to protected bald eagles is clear that things like fireworks should not occur within ½ mi of the active nest site. If we want to protect bald eagles and their young in Warner Park, then no fireworks is the best option.

This year the purple martin bird house located at the beach, was active and flourishing until after the fireworks when the volunteers managing the house found dead chicks all over the ground and the chicks in the house were found dead as well. The startled adults flew out and did not return which caused the chicks to starve to death. If we continue to host purple martin houses to help bolster the population around Lake Mendota, then no fireworks is the best option.

On July 3, during the large 23-minute concussive fireworks show, I was at Warner Park near the Rainbow Shelter building. The noise levels were well over 110 decibels and the smoke was so thick I had to leave the park. I could not breathe. I can only imagine the constant levels of particulates and other toxins in the air that families living in the housing near the park stadium endure each week during the Summer months of baseball. The particulate load alone is massive. No fireworks would alleviate this source of air pollution which is a current concern for our city as we conduct an air quality study that does not include Warner Park. Please include an air monitor in Warner Park near the stadium.

Many members of our community have spoken to their mental and physical anguish related to the fireworks. From a woman's 93-year old mother hiding out in her basement each week during the fireworks, enduring flashbacks from WWII to Vietnam Veterans speaking to their being traumatized by the fireworks. Families with little children losing sleep, and pet owners having to leave their home each week to stay in a motel. Fireworks need to stop.

Another issue for public park users is the lack of parking for the accessible playground and the fishing pier as the park is taken over by baseball fans using all the parking lots during game days. Keeping the accessible and fishing pier lot reserved for the public park users is important.

A drone show on July 4<sup>th</sup> is the best option. No game day shows. One major non-explosive display would be exciting, innovative and possible if the funds from Festival Foods (about \$50K) and from the other weekly fireworks shows were combined to purchase a state-of-the-art drone show for the Independence day show. Families could still spread their blankets in the stadium and enjoy the drone show. A drone show on July 4<sup>th</sup> is the best option to do no harm.

To decide to continue the fireworks is a decision to cause harm and trauma.

In the late 1960s, the Board of Park Commissioners and Parks Department decided to ban fireworks in Vilas Park "because of the mental and physical anguish suffered by elephants, zebras, and elands in the Vilas Zoo." (The Capital Times, June 13, 1968) If this government board could see its way to protecting zoo animals from harm caused by fireworks, it seems that we can choose to do something different and better for the community at large. The baseball games can continue to occur, people will come. Imagine no one having to cower in their basement and endure being traumatized, no pollution, no shock and death to wildlife and birds and we still can celebrate our 4<sup>th</sup> of July with a coming together at the stadium for a large drone show.

Consider the alternatives and we can celebrate the 4<sup>th</sup> of July knowing that we are doing no harm.

Please forgive me for having to email my comments to you about the Warner fireworks. I planned to give highlights from my comments during the community meeting this evening at the Warner Center, but an unexpected crisis prevented me from attending.

I spent several days putting together these comments with the intent of providing the specific kinds of information requested in the triage and feedback approach requested by Alder Burris. I also included some questions about the broader context to assist in evaluation of these concerns.

I hope these comments, suggestions, and questions are helpful.

# **Hello Alders Burris and Myadze:**

Thank you for holding this community meeting where people can provide feedback about the Warner Mallards fireworks. Thanks also to Justin Markovski for facilitating the meeting. I am Dolores Kester. I have owned a home on Winchester Street on the Northside since 1972. I have served on the board and as chair of the Sherman Neighborhood (District 12). I have served on the board of Wild Warner since its inception. I have practiced law in Wisconsin for not quite fifty years. The concerns expressed below are solely my own, and do not represent any group in which I participate.

You have asked that we focus on a summary of what worked and what didn't work during the last season, as well as the following:

what were concerns based on our perspective

- What was a concern that never materialized but should be noted; and
- What was unexpected

#### Five observations:

1. A member of Wild Warner who is an older gentleman is a well-known sponsor of and participant in fishing activities in Madison and Dane County. In fact the pier in the lagoon was named in his honor recognizing his contributions fo public fishing activities. On several occasions this summer tried to go to this pier to fish, but there was never any parking available because Mallards fans were using it all. This was brought to the attention of responsible individuals several times but no change has ever been made.

The same is true of the disabled playground area right next to that parking area. Any user coming to that playground could not use the space because there was no parking available for the public!

The parking lot for WPCRC is typically supervised by Mallards staff on game day to prevent fans from filling up that lot. Why is this not done at the non-city lot closest to Rainbow Shelter?

- 2. A concern that never materialized but should be noted: We are all just lucky that the three eagle chicks hatched this year did not suffer harm from fireworks despite Mallards rushing the first game of the season which had been planned for June 28<sup>th</sup> -- also planned for this year's first firework. In my opinin, liberties were taken in interpreting US Fish & Wildlife Guidelines under the federal statute that protects migratory birds related to a broad interpretation of the term "fully fledged" in US Fish and Wildlife Guidelines for the Migratory Birds federal statute. This decision was made by limiting the decision maker to a parks staffer with very limited public input other than communications with SWIBA. The point being that Mallards pushed the first fireworks date, potentially putting the safety of the three chicks at risk.
- 3. What was unexpected that needs to be addressed or highlighted or lifted up: Compare suicides of purple martin chicks in a recent study of birds in and around Warner Park, which jumped out of their nests when fireworks startled them. They all died. Ever wonder why there are so few purple martins around Lake Mendota?
  - 4. Mallards should not be launching their fireworks in the playing field at the corner of Northport Drive and N. Sherman Avenue. For one thing, I am reliably informed that this field is planned for use as children's sports fields. This area is also not the required distance from eaglets required under federal US Fish & Wildlife Guidelines, thus potentially putting at risk the safety of new chicks.
  - 5. Number of games and time of day of fireworks

This past summer season of fireworks connected with Mallards games, the number of firework events was for the first time in a number of years increased from 6 to 7. This is too many fireworks. The increase from 6 to 7 fireworks events was an unexpected change antithetical to the public's expectation that there would not be more than six such events. Several of these events were noisier than usual. Also, when games run late, often fireworks don't start until later, meaning that they run late into the night which is contrary to public expectation.

### Suggestions for short term solutions

- Roll back number of fireworks to 6 or less—goal should be drone show not oftener than once a year on the 4<sup>th</sup>
- City staff, quit treating the Mallards like they were members of your family
- Quit treating the public like uninvited guests at a party
- Forbid late fireworks shows
- Require reasonable parking and take other steps so the rest of the public can actually get access to their public park!!!

## Final questions and conclusions

Warner Park is a public park under the supervision and stewardship of the City of Madison, yet in regard to the fireworks and related issues, I submit to you that the public interest is not well served.

Mallards are tenants under a lease with the city for the purpose of holding baseball games in the buildings and other structures surrounding the stadium. They are not a city agency. However, when they have a game, the public is essentially excluded from any use of the front half of Warner Park because Mallards and their fans take over all the space, excluding any others' park use.

In other words Mallards lease a small area but in practice take over a much bigger area preventing public use in the front half of the park. Does this serve the public interest? Why does the city feel it is reasonable to lease a big part of our main Northside public park for so many years, in effect giving this commercial enterprise a monopoly and excluding competition--whose only concern is profit. The city thereby excludes most other public uses of that half of the park, causes death of wildlife and birds, and harm to public health from contamination of the soil and water. Why does city feel it is ok to give Mallards permanent use of most of the eastern part of the park for half of the summer every summer? Where is the public benefit? This is a public park, but not available for public use.

Why does city feel it is reasonable to lease a big part of our main public park giving this commercial enterprise a monopoly excluding competition. The city thereby excludes most other public uses of that half of the park, causes death of wildlife and birds, and contaminates the soil and water permanently?

Why does city feel it is ok to give Mallards permanent use of most of the park for half of the summer every summer? Where is the public benefit? This is a public park, but not available for public use for significant periods of time over many years.

Is this lease arrangement with Mallards fair to the public interest? are its fiscal terms reasonable?

Is this contract with Mallards fair to other potential entrepreneurs who might obtain benefit from holding recreational events in this location?

I join others on the Northside in looking forward to working with you on fair solutions that permit balanced and equitable uses of Warner Park with opportunities available to all members of the public.

I've since taken the time to learn a little about "Love My Air" and the availability of air quality sensors. From involvement in the community that predates my work in this office, I know that Madison has long had an air quality issue, and we know that environmental issues have a disparate impact on marginalized communities. The installation of a city-wide network of air quality sensors is such a promising way to understand the distribution of potential air quality issues across the city, and I'm glad to see attention to the Northside, with its concentration of economic challenge and diverse population.

We represent the Northside of Madison, including Warner Park and the surrounding area until the end of the year and session, at which point the area will be in the 76<sup>th</sup> Assembly District, represented by Rep. Hong, cc'd here. I hope we might have a chance to meet in person or have a phone conversation next week or the following week, so I can be as updated as possible, and have the opportunity to advocate for all measures that will illuminate the air quality in our district. I am writing to request that firework displays permanently cease at Warner Park. The beautiful lights in the sky are serious detriment to public health and safety, pets, wild animals and birds, and our environment, and you are accountable to act in the best interest of public safety and health and welfare.

In the past the City of Madison eliminated fireworks due to the negative impacts and public outrage at Vilas Park, Law Park, and others including Warner Park Rhythm and Booms events. The reasons are still the same, people frightened by the sounds and sickened by the smoke, animals scared to the point of death, toxic smoke and hazardous chemical firework components, poisoning the park grounds, watersheds, and groundwater.

If fireworks negative impacts and effects on the people, animals and environment haven't changed, why then were they allowed to return after the ban in 2013? Failure to act in the best interest of public safety and health and welfare and baseball. Mallards Baseball.

Baseball? What does baseball have to do with fireworks? You take the family out to the ballpark, sit back watching a great game, kids participate in fun activities, eat a hot dog, cheer, buy some swag and experience baseball as it always has been, a great family activity. An experience that fills the Warner Park Duck Pond to capacity. Then fireworks, why?

Your family and the surrounding two-mile area are bombarded with sound decibel levels exceeding 110, the air is filled with perchlorate, and heavy metals, sodium, barium, strontium, magnesium, chromium from the firework gases and particles at levels 49 times higher than considered safe by OSHA, then becomes fallout and contaminates the ground, ballpark, Warner Park, and surrounding neighborhoods.

Overtime, all firework perchlorate and heavy metals either remain in the soil surface to expose humans, pets' flora and fauna throughout the parks and playgrounds or are moved by rain into the storm sewers, Warner Lagoon and Lake Mendota. It is not conjecture, it is science-based fact and a public health hazard that has the same cumulative effects as the former Rhythm and Booms shows and on everyone's health and environmental future.

Baseball alone is quite a bit safer for families than fireworks. I love baseball and am very grateful for what Mallards and the Mares ball games bring to generations of family experiences, memories, and our neighborhood. However, when considering the facts surrounding the negative impacts, as well as the discontent, disruption and ill effects impinged upon the constituents, PTSD survivors, pets, wild animals, of the neighborhoods surrounding Warner Park it is the correct decision to ban fireworks

Mallards and Mares baseball have before and will again, fill the stadium without fireworks and safe alternate form of sky entertainment such as drone shows are always a possibility to satisfy the needs for the 4th of July. There are safe alternatives, so why not use them rather than continuing the firework attack on the public and environmental health.

Clearly past members of the Board of Parks Commissioners were accountable and acted in the best interests of public safety, health and welfare and their constituents. I ask you to do the same, and request that you take immediate steps to cease and permanently ban fireworks displays at all locations at Warner Park in the future.
