Jim O'Keefe provided City and County budget updates, and updates regarding the use of ARPA funds – with updates on the St Johns Redevelopment project, Porchlight, The Salvation Army, and the Dairy Drive campground.

The City's CDBG Unit has been able to put CDBG funds - which are obligated to be used on a timely basis - to legitimate use to get beneath the federal government's annual timeliness standards.

Linette Rhodes - The CDBG committee will have to have public hearings in 2024, which will need to be in person, however, we do not intend for the January or February meetings to be in person. Staff will be working on a year-at-a-glance workplan calendar to be shared with the committee.
